#### Motion #2

The Management Committee ("MC") hereby recommends that the Board of Directors approve the revisions to Sections 6.10, 22, 25.5, 25.7, 31.1, 31.2 – 31.2.7, 31.3, 31.5, 31.7, and new Sections 31.13 and 31.14 of the Open Access Transmission Tariff, and revisions to Section 30.4 of the Market Administration and Control Area Services Tariff, as more fully described in the presentation entitled "Economic Planning Process Tariff Revisions" as presented and discussed at the December 16, 2020 MC meeting.

The motion was approved unanimously.

## Joint Installed Capacity/Market Issues/Price Responsive Load Working Group

Informational LCR Results

Ryan Carlson of the NYISO updated the Locational Capacity Requirement values following the determination of the final Net Cost of New Entry (CONE) curves. The preliminary Transmission Security Limits (TSLs) for 2021 were also provided using the October load forecast and Final Base Case EFORd values.

Mr. Carlson provided the final Net CONE curve values for discussion with stakeholders. The preliminary TSL limits are:

## FERC Order No. 2222

Michael Ferrari of the NYISO reviewed FERC Order No. 2222 (Order) and indicated the parts of the DER Participation Model that the NYISO may need to modify. FERC issued the Order, Participation of Distributed Energy Resource Aggregations in Markets Operated by RTOs and ISOs, on September 17, 2020.<sup>1</sup>

The rule requires ISOs and RTOs to permit DER participation alongside traditional resources in the organized wholesale markets through aggregations. DER must be permitted to aggregate in order to satisfy minimum size and performance requirements that each may not be able to meet individually. Mr. Ferrari led a discussion summarizing the requirements of the Order.

Mr. Ferrari then compared the NYISO participation model to several of the requirements of the Order for stakeholder information and discussion.

The NYISO is still evaluating the Order and how the NYISO intends to comply with the Order. In response to a stakeholder question, Mr. Ferrari noted that the NYISO will return for further stakeholder discussion of the issue in Q1 2021. #### Installed Capacity Manual Revisions

Sarah Carkner and Emily Conway of the NYISO presented proposed Installed Capacity Manual (ICAP) revisions for stakeholder discussion. The revisions reflect updates to the Expanding Capacity Eligibility and the Tailored Availability Metric rules.

Ms. Conway next detailed the proposed updates to the ICAP Manual Attachments M and J. The NYISO is seeking stakeholder feedback on the proposed ICAP Manual and Attachment revisions discussed at the meeting. The NYISO will return to an upcoming ICAPWG as needed to continue discussions on the topics and is aiming to bring the proposed revisions to the ICAP Manual and Attachments to the BIC in early 2021. #### Salesforce - Knowledge Base

Mark Seibert of the NYISO presented the NYISO Knowledge Base. The Knowledge Base, located on the NYISO web site, provides access to a centralized library of information on current and emerging industry related topics. The benefits of the Knowledge Base portal are:

#### BSM Self Supply Exemption Compliance Filing (Docket ER16-1404)

Shaun Johnson of the NYISO reviewed the NYISO BSM Self Supply Exemption Compliance filing. In April 2016, NYISO filed a compliance plan with FERC that, among other things, proposed to create a Self-Supply Exemption in the BSM Rules. On February 20, 2020, FERC ruled on the NYISO compliance filing. FERC generally accepted the NYISO's compliance filing, however, the order directs the NYISO to submit a compliance filing that limits eligibility for Self Supply LSEs to non-State entities; requires modifications to the Net Long and Net Short Thresholds; and directs the NYISO to include an additional process step prior to the NYISO revoking a previously awarded Self Supply Exemption. The NYISO's response is due December 21, 2020.

Mr. Johnson detailed the compliance filing tariff language to stakeholders for review and discussion. Tariff redline copies were provided with the meeting materials.
