Click on View Filing, Docket, or View Order links to view the related documents.



The back button will return to the previous item viewed

## TARIFFS

Hover on the **TARIFFS** button to see the list of tariffs. Slide to the submenu to select one of the following:

- **PDF – Full Tariff:** print the entire currently effective tariff
- **PDF – Select Sections:** select multiple tariff sections to print a custom document
- **Quick View:** view a specific, currently effective tariff section
- **Filing History:** view all filings related to a certain tariff section, along with the Docket number and Status

## FILINGS

Hover on the **FILINGS** button and slide to the submenu to select one of the following:

- **NYISO:** filings the NYISO has submitted on its own behalf.
- **Third Party:** filings the NYISO has submitted on behalf of other companies

## DOCKETS

Hover on the **DOCKETS** button and slide to the submenu to select one of the following:

- **NYISO:** proceedings related to NYISO filings.
- **Third Party:** proceedings related to Third Party filings.

## ORDERS

Hover on the **ORDERS** button and slide to the submenu to select one of the following:

- **NYISO:** orders issued in NYISO dockets.
- **Third Party:** orders issued in Third Party dockets.

## Download and print Tariffs, Filings, Dockets and Orders in PDF format

### Printing Tariffs

The **TARIFFS** or tariff sections can be downloaded and/or printed from each of the tariff submenu option pages. Hover on the **TARIFFS** button to highlight one of the tariffs. Slide to the submenu and select one of the following:

- **PDF – Full Tariff:** opens a PDF of the selected tariff. Not available for “Agreements”.
- **PDF – Select Sections:** Check the boxes on the left to select the individual tariff sections to download/print in a PDF. All sections that are selected will be in one PDF document. Click the View/Print PDF Button to view/download.
- **Quick View:** click the + signs to open the list of tariff sections on the left. Select a section to make the language of that section appear on the right along with a View/Print PDF button in the top right corner. Click the print button to open just that section in PDF format.
- **Filing History:** click the + signs to open the list of tariff sections at left. Select a section to make QUICK VIEW, VIEW/PRINT PDF, and the Filing History for that section appear on the right. Click on VIEW PRINT/PDF to download/print that section.

### Printing Filings, Dockets and Orders

Hover on the **FILINGS, DOCKETS, or ORDERS** button and select “NYISO” or “Third Party” from the submenu.

- **FILINGS and ORDERS:** click the + signs on the left to expand the date structure of the filings or orders. Click on the filing or order description to view the filing or order documents and related filings, orders, and dockets on the right. Click the links provided to view the related pages.
- **DOCKETS:** click on a docket number on the left to view the filing document and related filings, orders, and dockets on the right. Click the links provided to view the related pages.



#### Search Filters

Start Date:   End Date:   Source: Search All   Word or Phrase:

- **Start Date and End Date:** (optional). Type in a date or use calendar icons to specify date range.
- **Source:** (optional). Select a “Source” from the dropdown.
  - **Master Tariff:** searches tariff sections only
  - **Filings– All Documents:** searches all filing documents
  - **Filing Letters:** searches transmittal letters only
  - **Dockets:** search docket NUMBERS only
  - **Orders:** searches order documents only
  - **Search All:** default to search all the above
- **Word or Phrase:** (required). Type in a key word or phrase in the text box. If source is a docket the text must be a form of a docket number Ex: ER17-1234 or ER17 or AD-1234-001. Click  or type enter to retrieve results from the search filters.

#### Search Results:

- **Master Tariff:** results will list tariff section title, current effective docket number and current effective date
- **Filings–All Documents:** results will list filing title with respective docket number and filing date
- **Filing Letters:** results will list filing title with respective docket number and filing date
- **Dockets:** results will list docket number with respective filing title and filing date
- **Orders:** results will list order title with respective docket number and issuance date
- **Search All:** results will list titles of tariff sections, dockets, filings, or orders, with the source of each and its respective effective, filing, or issuance date
