II. Motion to Intervene

On February 14, 2007, Linden VFT, LLC ("Linden") filed a petition for authority to makes sales of transmission rights at negotiated rates in connection with its proposed merchant

transmission project that will provide 300 MWs of additional transmission capacity in the New

York City area and for acceptance of an open season report for the auction recently held for the

initial allocation of that new transmission capacity. The Linden project is currently on the

NYISO's interconnection queue.

The NYISO is the independent body responsible for providing open access transmission

service, maintaining reliability, and administering competitive wholesale electricity, ancillary

services and capacity markets in New York State. As a control area operator and capacity

market administrator, the NYISO has a direct and substantial interest in the matters being

addressed in the Linden proceeding. Specifically, additional transmission capacity into New

York City could affect the NYISO's capacity markets and reliability planning processes.

The NYISO's interests cannot be adequately represented by any other party to the Linden

proceeding. Accordingly, the NYISO respectfully requests that the Commission permit it to

intervene in the above captioned proceeding, pursuant to Rules 212 and 214 of the Commission's

Rules of Practice and Procedure, 18 C.F.R. §§ 385.212 and 385.214.
