III. Service List

Copies of this filing are being served on all parties designated on the official service list maintained by the Secretary of the Commission in this proceeding. The NYISO is also serving a copy of this filing on the New York State Public Service Commission and the electric utility regulatory agencies in New Jersey and Pennsylvania.

IV. Description of the Proposed Changes

The NYISO's Real Time Scheduling (RTS) filing had originally proposed that if a Supplier offers resources in the Day-Ahead Energy Market that are capable of providing Operating Reserves, but does not submit an Availability Bid for Operating Reserves, the resource would have been assigned a Day-Ahead Availability Bid of \$0/MWh up to the quantity of capacity that it made available to the NYISO in its Day-Ahead Bid ("the default bid rule"). Pursuant to the Commission's May 7 Order, the NYISO hereby submits revised tariff sheets that replace the default bid rule with a rule that will automatically reject Day-Ahead offers from Suppliers bidding ISO-Committed Flexible or Self-Committed Flexible capacity if those offers do not include a Day-Ahead Availability Bid for Operating Reserves.

Specifically, Services Tariff § 4.2.2 C1 and § 4.2.2.2 I, Rate Schedule 4 § 2.1 and Attachment D, Table D-6 are being revised to replace the default bid rule with the bid rejection language as described above and as shown in Attachments I and II of this filing.

In accordance with existing procedures, suppliers submitting bids through the NYISO's Market Information System (MIS) web interface or the Upload/Download batch procedures can check the status of their bid. If a Day-Ahead offer for ISO-Committed Flexible or Self-Committed Flexible capacity is rejected because there is no Day-Ahead Availability Bid for

Operating Reserves, the bid status will show that the bid validation failed. The Supplier will then be able to resubmit a valid offer, if desired, any time prior to the Day-Ahead Market deadline.

VI. Conclusion


