ORDER GRANTING REHEARING FOR FURTHER CONSIDERATION

As provided in 18 C.F.R. § 385.713(d), no answers to the rehearing requests will be entertained. The Commission anticipates issuing an order on the merits in this proceeding by October 31, 2001.
