To the extent that such a methodology is approved and implemented, any separately identified TCC and congestionrelated values would be used to adjust the otherwise applicable charges for the Ramapo PARs under Rate Schedule 1 of the OATT on a going forward basis. The tariff revisions necessary to implement any such methodology and to account for any separately identified TCC and congestion-related values in the calculation of the charges for the Ramapo PARs under Rate Schedule 1 of the OATT will be subject to review and approval through the normal stakeholder shared governance process; provided, however, that this separate initiative shall not delay or otherwise impede the process for implementing the tariff revisions approved by the MC on May 31, 2017.
