Motion #1:

Motion #3

The Management Committee hereby agrees to approve and adopt the amendment to its By-Laws as presented at the October 11, 2005 Management Committee meeting.

(Motion passed by show of hands with one vote against: DC Energy)

Motion #4

Pursuant to Section 9.02 of the recently-approved amendment to the Management Committee By-Laws, the Management Committee hereby activates the Board Selection Sub-Committee ("BSSC") and request that each sector designate its two BSSC representatives and two BSSC alternate representatives no later than October 18. The names of these representatives and alternate representatives should be conveyed to the Chair of the Management Committee.

Motion #5

WHEREAS: The NYISO and its market participants have been discussing self supply of operating reserves since 2000. These discussions have, at various times, include discussions of possible designs for physical self supply options.

WHEREAS: The Management Committee is of the opinion that physical self supply is not a necessary option for the New York Market at this time. Designing a physical self supply option within the basic framework of the New York Market would be a complex and time consuming process. Although no option should be completely discarded as unwarranted, we believe that further exploration of physical self supply options at this time would be unproductive and unnecessary.

WHEREAS: The NYISO and its market participants are exploring the need to enhance or expand upon the two financial self supply options that are currently available under the NYISO's Market Administration and Control Area Services Tariff, Rate Schedule 4.

WHEREAS: The Management Committee concurs with the NYISO's current plan to continue to evaluate operating reserves price data and other market and system information for the purpose of making a recommendation to the market participants in 2006 on whether another financial self supply option(s) is necessary. Based on such recommendation and the results of the underlying analysis, the market

participants will decide in 2006 whether they choose to proceed with the design of an enhanced self supply option.

WHEREAS: The Management Committee encourages the Commission to allow the New York market to continue its analysis of the need for another financial self supply option and allow it to end, for now, any further effort towards a design of a physical self supply option for operating reserves.

NOW, THEREFORE, IT IS MOVED THAT the Management Committee approves amendments to the current tariff to clarify that physical self supply is not available in the New York Market at this time and identifying the two financial options that are currently noted in the tariff as the only presently available self-supply options.

The Management Committee also requests that the NYISO continue to monitor the price differentials between east and west and further analyze the production costs savings as identified in the LECG Report presented to the 9/21/05 BIC and make a recommendation in 2006 on the need for a further financial hedge and/or locational reserve settlements.

The Management Committee also recommends that if a further financial hedge is determined by the NYISO and its stakeholders to be necessary, that the NYISO include in the development of that hedge an evaluation of the feasibility, costs and benefits of optimizing transmission capacity for reserves. Any improvement in the reserve cost hedging mechanism that would contain a move to locational settlements would also have to address the potential need for transmission optimization at that time.

Motion # 6a

The Management Committee (MC) hereby approves revisions to the NYISO Voltage Support Service program, as noted below, and recommends that the Board of Directors support a tariff filing to implement these changes:

- 1. To move to Net Lagging at the point of interconnection compensation measurement
- 2. To provide clarification of testing requirements, as presented to the Business Issues Committee at the August 24th meeting
- 3. To the extent that a supplier does not have access to data from a net MVAr meter, to require the NYISO to calculate a value based upon a gross MVAr reading at the unit at issue and an established power flow calculation
- 4. To revise the 2006 revenue requirement and the annual revenue requirement for future years for this service as follows:
 - a. Update the 2001 revenue requirement to reflect new additions and retirements as of October 31, 2005 (the "Updated Requirement");
 - b. Apply a 3% annual inflation component to the Updated Requirement to reflect inflationary impacts associated with 2004 and 2005; and
 - c. At the end of each year, use the inflation index method that has been determined by the MSWG and approved by the BIC in accordance with the six month process set forth below to determine the inflation factor that reflects the actual inflation rate for that year and adjust the then existing dollar per MVAR rate accordingly for the upcoming year.

- 5. Add a new provision to Rate Schedule 2 that creates comparable payment terms for merchant non-generator dynamic VAR sources that are interconnected to the transmission system. These provisions would include:
 - a. Prorated VSS payment for energized hours for VAR capability measured at full real power flow
 - b. No lost opportunity cost payments and no requirement that the source change real power schedules; except that nothing in this motion shall be construed to change existing protocols between the New England ISO and the New York ISO
 - c. Interim testing procedures that allow facilities to test out of period
- 6. Delete, as presented to the BIC on September 21st, the section from Rate Schedule 2 that requires Voltage Service payments to Non-Utility Generators ("NUGs") operating under existing power purchase agreements to be provided to the entity purchasing the NUG's Energy or Capacity, unless otherwise stipulated by that entity

In addition the MC directs that MSWG develop a proposal for BIC and MC action within 6 months that includes the following:

- a. Review of the base compensation amount for VSS providers under Rate Schedule 2 and whether, and, if so, how, the base amount of Rate Schedule 2 should be adjusted on an annual basis.
- Determination of the preferred method (in terms of fairness, simplicity and feasibility)
 to allocate VSS costs to loads based on system needs and locational reactive power
 requirements
- c. The appropriateness of payment for the costs of energy consumed and any startup costs for non-generator VAR sources

Finally, the MC directs that, as part of the triennial process for resetting the ICAP demand curves, the NYISO shall evaluate whether the gas turbine that represents the proxy for the cost of new entry should include the equipment necessary to provide, and would be capable of providing, voltage support service, and, if so, the expected net revenues associated with the rendition of that service should be included in the ancillary service revenues calculated for the gas turbine.

Motion # 6b

Motion to amend original Motion 6a as follows:

The Management Committee (MC) hereby approves revisions to the NYISO Voltage Support Service program, as noted below, and recommends that the Board of Directors support a tariff filing to implement these changes:

- 2. To provide clarification of testing requirements, as presented to the Business Issues

- 4. To revise the 2006 revenue requirement and the annual revenue requirement for future years for this service as follows:

 - b. Apply a 3% annual inflation component to the Updated Requirement to reflect inflationary impacts associated with 2004 and 2005; and

- Determination of the preferred method (in terms of fairness, simplicity and feasibility)
 to allocate VSS costs to loads based on system needs and locational reactive power requirements
- c. The appropriateness of payment for the costs of energy consumed and any startup costs for non-generator VAR sources

Finally, the MC directs that, as part of the triennial process for resetting the ICAP demand curves, the NYISO shall evaluate whether the gas turbine that represents the proxy for the cost of new entry should include the equipment necessary to provide, and would be capable of providing, voltage support service, and, if so, the expected net revenues associated with the rendition of that service should be included in the ancillary service revenues calculated for the gas turbine.

Hold items 4b and 4c in abeyance pending completion of additional study on these items by March 31, 2006 to be developed, reviewed and reported on by the MSWG with the stipulation that subsequent approval by the MC of a cost adjustment factor applied to the 2002 base rate would be made retroactive to January 1, 2006 or such other measures would be adopted to ensure that suppliers received a total payment for calendar year 2006 equal to what they would have received if the cumulative cost adjustment factor, if any, had commenced on January 1, 2006.

Motion # 6c

Secondary Motion re: Extension of Voltage Support Service Program through March 31, 2006:

WHEREAS, the Market Participants at the Market Structures Working Group of the New York Independent System Operator (NYISO) discussed modifications to rates, terms and conditions of the Voltage Support Service compensation in Rate Schedule 2 of the Services Tariff;

WHEREAS, the Market Participants at the Business Issues Committee did not approve various motions addressed to these issues, and additional time is desired for their resolution;

WHEREAS, the Voltage Support Service rate in Rate Schedule 2 shall expire by its own terms on December 31, 2005, leaving no basis for compensation to providers of voltage support in New York State

NOW, THEREFORE, the Management Committee of the NYISO hereby approves a motion to recommend to the Board of Directors that a filing be made by the NYISO under Section 205 of the Federal Power Act to request that the Federal Energy Regulatory Commission (FERC) extend the Voltage Support Service rate in Rate Schedule 2 under the present rates, terms and conditions, through March 31, 2006, and that the FERC waive the minimum 60-day notice period for the effectiveness of said rate filing.
