MOTION OF THE NEW YORK INDEPENDENT SYSTEM OPERATOR, INC. FOR LEAVE TO ACCEPT STATUS REPORT COMPLIANCE FILING ONE DAY OUT OF TIME

Pursuant to Rule 212 of the Commission's Rules of Practice and Procedure,¹ the New York Independent System Operator, Inc. ("NYISO") hereby seeks leave of the Commission to accept one day out of time its electronically-submitted compliance status report pursuant to the Commission's October 25, 2001, Order ("October 2001 Order") in the above-captioned proceeding.²

The Commission's October 2001 Order, which extended the effectiveness of the NYISO's then-applicable Temporary Extraordinary Procedures Authority and a \$1,000 MWh bid cap on certain types of bids into the NYISO-administered energy markets, also directed the NYISO to file bi-annual reports, beginning December 1, 2001, on the status of demand response programs and the addition of new generating resources in New York. All past bi-annual reports have been submitted to the Commission in compliance with the October 2001 Order.
