NYISO Business Issues Committee Meeting Minutes

NYS Nurses' Association, 11 Cornell Road, Latham, NY 12110

I. Welcome and Meeting Objectives

Larry DeWitt, Chair of the Business Issues Committee (BIC), called the meeting to order at 9:29 A.M. and welcomed the members of the BIC. The attendees introduced themselves and named the companies that they represent.

II. Approval of Minutes

A draft of the June 10, 2003 BIC meeting minutes were distributed to the BIC members prior to the meeting. Robert Gow, of NYPA, moved the motion to approve the minutes. Jeffrey Gerber, of NYSERDA, seconded the motion. By a show of hands, the Committee members approved the June 10, 2003 BIC meeting minutes and its amendments.

Motion #1:

Motion to approve the minutes from the June 10, 2003 Business Issues Committee Meeting.

(Motion passed unanimously by a show of hands)

III. Chair's Report

Mr. DeWitt noted changes in the order of several agenda items to be addressed.

IV. Price Responsive Load Working Group Report

Robert Loughney, Chair of the PRL WG, and David Lawrence, of the NYISO, presented a status of the NYISO's Demand Response Programs. Mr. Lawrence noted that the PRL WG has been putting together the details of how the Real-Time Demand Response Program will operate under SMD. He also outlined changes to the DADRP. Howard Fromer, of PSEG, asked if the NYISO knows if all the ICAP SCRs would be able to run in an emergency. Mr. Lawrence responded that the application form for SCRs asks organizations to abide by all applicable environmental regulations; however, there is no requirement for organizations to provide the NYISO with their DEC registration certificates.

Mr. Loughney noted that the PRL WG is striving to complete the project on a conceptual level and once the project is worked through, it will be presented once again to the BIC members. Tariq Niazi, of the NYS Consumer Protection Board, asked about the current level of participation in the DADRP. Mr. Lawrence replied that the level is at 15-20 MWs.

Mr. Kinney noted that restrictions might be in place at the NPCC level, which will limit the

amount in the market of non-synchs. Mr. Lawrence responded that the NYISO is working with the NPCC and the NYSRC to revise the definitions.

V. Market Operations Report

Charles King, of the NYISO, reported on Market Performance highlights and a look at reliability indicators. Mr. Kinney asked if any progress has been made looking at the costs of high control performance. Mr. King agreed to check on the status as an action item. Mr. King also noted that for June 2003, the NYISO administered total costs rose due to the hot weather. Also, regulation and reserve prices have dropped since the market is operating at higher levels and with more commitments.

VI. Regional Market Enhancements

Mr. King updated the Business Issues Committee on the Northeast Seams Issues.

Stuart Nachmias, of Con Ed, asked if a report will be done on how often scarcity pricing is implemented in New York and Mr. King replied that the NYISO indeed plans to construct this type of report. Mr. King added that whenever scarcity pricing does occur, it will be announced on the "pricing page" of the Website.

Larry DeWitt asked about the participation levels for Virtual Regional Dispatch. Mr. King responded that the meetings with Market Participants have had strong, lively participation and that the NYISO is still fleshing out a straw proposal for the next meeting on July 31st.

Tariq Niazi asked if Mr. King could summarize the outcome of the second meeting that occurred in Springfield. Mr. King said that the NYISO presented information on the value and the appropriateness of Virtual Regional Dispatch. He noted that some were confused on the intent since the NYISO seemed to focus too heavily on the Independent Market Advisor's view. He added that Morgan Stanley's paper shows a broader view of what the NYISO is trying to accomplish.

Mark Younger pointed out that if we do Virtual Regional Dispatch, we've violated basic requirements. Therefore, we need to remove limitations, not implement Virtual Regional Dispatch, or come up with perfect price curves. Mr. King agreed that it's an issue that needs to be addressed and stated that Bob Thompson, of the NYISO, is looking into it. Howard Fromer stated that in looking at the history of seams issues, it's a desire of Market Participants to schedule transactions closer to Real-Time Operation. He added that it would be useful to mark this issue as outstanding while under the current software. Mr. King responded that if it's still currently an issue, the NYISO will place it on the Open Issues List.

VII. Billing and Accounting Working Group (BAWG) Report

Kevin Kipers, BAWG Chair, presented a status report on the 12-month final bill process. He noted that three deliverables currently remain open.

Timothy Bush, of Navigant Consulting for MEUA, expressed his concern with the process and noted that he doubts the final bill process will happen in a year. Mr. Kipers replied that the WG has been concentrating on what's been filed with FERC. Mr. Bush added that "as accurate as possible" doesn't meet his standards and that the bills must be implemented correctly.

Mr. Nachmias asked if the 8/12 date for the Web Based Reconciliation is realistic. Mr. Kipers responded that it's uncertain if that date can be met and BAWG is concerned, but there has been good progress.

Wesley Yeomans, of National Grid, pointed out that he sees two core problems in eliminating the 24-month true-up: (1) the NYISO doesn't have a centralized data exchange to coordinate communications, which makes the current system cumbersome to use; and (2) the Tariff changes occur faster than the NYISO's IT group can get them reflected in the software. Andrew Ragogna, of the NYISO, responded that the NYISO recently slipped the project by a month and has performed additional testing. He also noted that LSEs need time to validate their results. Jim McGinnis, of the NYISO, presented the Committee Members with a plan that the NYISO envisions implementing: (1) expanding the testing period to five days; (2) expanding the documentation of the process in a User's Guide; (3) sending notifications from NYISO Customer Relations; (4) holding conference calls on a daily basis; and (5) presenting a training session in August for those who will interact with the Web-based application. Mr. Ragogna added that it's necessary to get the billing cycle shortened. He also agreed that the bills need to be accurate.

Mr. Nachmias asked if any opportunity exists for the existing system and the new system to run in parallel or if any flexibility exists to make the first couple of bills 13 months. Mr. Ragogna replied that some flexibility exists.

Mr. Bush noted that since Market Participants, as a whole, haven't had the opportunity to test Web Based Reconciliation yet, it would be best to delay implementing it until January of 2004.

Ray Kinney, of NYSEG, asked if existing Tariff requirements would be kept in place if Web Based Reconciliation were delayed. Jane Lathrop, of the NYISO, noted that the NYISO can ask FERC for expedited treatment and that a vote at the Management Committee would be needed to make a filing to delay the October 2003 implementation date.

VIII. SMD 2 Project Update

Peter Lemme, of the NYISO, provided the SMD2 User Update. He addressed issues such as documentation, the SMD2 Website, training opportunities, customer support, and Market Trials. Mr. Kinney encouraged the NYISO to bring some of the SMD2 information from the MSWG meetings to the BIC and the MC. Ms. Robinson noted that as documents are posted, Market Participants can contact the NYISO to get additional information.

Mr. Fromer asked if a Tariff that's been reviewed by the Working Groups will be brought to the BIC and the MC. Bradley Kranz, of the NYISO, stated that the Committees will see draft Tariff language and the MC will ultimately have the opportunity to vote on the official Tariff language. Mr. Fromer also asked if the NYISO is keeping track of unresolved issues. Mr. Lemme noted that the NYISO is tracking these issues and that progress on the open issues is regularly reported at the MSWG meetings.

IX. TCC Markets Report

Gregory Williams, of the NYISO, presented on the Autumn 2003 Initial TCC Auction Plan. The plan includes a preliminary schedule outlining upcoming activities and the week they are proposed to be implemented.

Mr. Fromer asked if the NYISO has looked at how TCC Auctions have functioned in ISO-NE and PJM and if so, are they going through the same number of rounds that the NYISO has planned. Mr. Williams responded that they aren't since each has different needs. Mr. Fromer said he is concerned that as we move forward it will be more important that long-term TCCs become available in the market and it becomes a cumbersome problem to offer a greater array of products. He also noted that what the NYISO is proposing makes sense but he is concerned with what will happen in 2004.

X. Working Group Updates

- **A.** Electric System Planning WG (Chair Bill Palazzo) The joint OC/BIC WG Chair provided a full presentation on the status of its progress to date specifically Mr. Palazzo summarized the group's discussion of congestion and the planning process. He also noted what's included on the ESPWG's next meeting (7/18/03) agenda and he reviewed a list of issues for future consideration. Mr. Yeomans asked if voting on ESPWG-related items will occur in only one of the Committees BIC or OC? Mr. DeWitt replied that only the OC will be voting on proposals from the WG.
- **B.** Scheduling and Pricing Working Group (Chair Ray Kinney) S&P WG is in the process of scheduling a meeting for July 31st, but it may be rescheduled. The WG received an update on Scarcity Pricing and has begun discussion on Operating Reserves.
- **C.** ICAP WG (Chair Howard Fromer) The ICAP WG Meeting scheduled for 7/7 was rescheduled to 7/25 since some agenda items weren't fully developed. Among the topics to be discussed at the next meeting are: manual revisions and a presentation from LIPA on UDR-related issues. Mr. DeWitt noted that the regional RAM group's activities are important and need to be communicated to the BIC. Mr. Fromer noted that Mr. Charlton is the main contact on this issue but there's also been discussion about how to provide greater communication on this. Mr. Charlton added that anyone who wants to be on the RAM mailing list can sign up for updates and that a conference on Demand Response has been planned.

D. Market Structures WG (Chair – Jim Scheiderich) – No report was provided.

XI. Regulation Market Modifications Presentation

Gregory Campoli, of the NYISO, presented an analysis of the proposed action plan for NYCA variable regulation requirements.

Mr. Younger inquired as to when Mr. Campoli plans to return to the BIC to receive their approval before implementation. Gerald Deaver, of the NYISO, replied this doesn't need Committee approval because it is not a Tariff modification, but an administrative procedure. Doreen Saia, of Mirant, said these modifications could have serious business implications since it's a change in business practices.

William Heinrich, of the NYS DPS, noted that each year, the NYISO has a CPS1 and CPS2 performance goal, which is set very high. Mr. Heinrich asked if the market is paying too much for that high performance and if these proposed modifications are addressing that concern.

Christopher Wentlent, of AES, asked why the change to regulation was being brought about in the middle of a peak period. Mr. Campoli responded that the numbers probably won't change a great deal if the modifications are implemented at another time. Ms. Saia agreed with Mr. Wentlent's concern and added that the NYISO had planned to inform the Market Participants of the numbers a few weeks before August 1st. She asked why the information hasn't been provided by now. Mr. Campoli noted that the August 1st date is not definite and that they may roll the modifications into mid-August to allow ample time to be given to Market Participants.

Mr. Wentlent asked if a unit were off base-point would the NYISO automatically default to the Market Monitoring Unit or would the issue be sent to Operations instead. Mr. King noted that the NYISO examines persistent, not momentary problems. Mr. Fromer asked how other Control Areas go about acquiring regulation and Mr. King took it on as an Action Item to bring that type of analysis back to the Market Participants.

XII. Operations Report – June 26 & 27, 2003

Gregory Campoli, of the NYISO, presented on the June 26 and 27, 2003 Operations Report.

Mr. Fromer asked if there was any way to put the information from the "NYISO Loads" chart (first chart in the presentation) into context since it's unclear as to whether it indicates good performance or something with which to be concerned. Mr. Canino added that without having a weather forecast available it is difficult to come to any conclusions on the information presented. Mr. King agreed to take on an Action Item to provide further detail in the Operations Report regarding the NYISO Load (actual vs. forecasted) Chart by including a weather forecast so that performance can be evaluated.

Mr. DeWitt asked if any observation was made on pricing behavior during these peak days. Mr.

King replied that no, but the NYISO will strive to look at this for future instances.

XIII. New Business

No new business was discussed.

XIV. Administrative Matters

The Action Items List is included as part of the BIC meeting material. BIC members were reminded to contact Ray Stalter, of the NYISO, with any Action Item-related inquiries.

XV. Adjournment

Mr. Dewitt adjourned the meeting at approximately 12:40 P.M.
