**Re: *New York Independent System Operator, Inc.*, Docket No. ER07-570-000  
Notice of Implementation of the Dennison Scheduled Line**

Dear Ms. Bose:

On February 23, 2007 the New York Independent System Operator, Inc. (“NYISO”) filed proposed revisions to its Open Access Transmission Tariff (“OATT”) and Market Administration and Control Area Services Tariff (“Services Tariff”) in which it sought to implement two new Scheduled Lines<sup>1</sup> -- the Dennison Scheduled Line and the Neptune Scheduled Line.<sup>2</sup> In its transmittal letter, the NYISO committed to providing two weeks’ notice prior to implementation of each of these new Scheduled Lines to the Commission, all NYISO Market Participants, and the affected External Control Area operators.

In accordance with its prior commitment, the NYISO hereby provides notice to the Commission, Hydro Quebec Transenergie (“HQ”), Cedar Rapids Transmission Company (“CRT”) Alcoa Power Generating, Inc. (“APGI”) and to New York Market Participants that it expects to fully implement the Dennison Scheduled Line in its Day-Ahead and Real-Time Markets on market day October 1, 2008. The NYISO is coordinating its implementation with HQ and CRT, which are responsible for administering transmission reservations over the Dennison Scheduled Line in the HQ Control Area.

This notice will be served on the official service list in this proceeding and will be posted on the NYISO’s website. Should the NYISO determine that it will be unable to implement the Dennison Scheduled Line on or about October 1, 2008, it will promptly notify the Commission, HQ, CRT, APGI and New York Market Participants.
