Compliance Report on the Status of Settlement Discussions Regarding the Netting Bilaterals Project in Docket Nos. ER03-552-012 and ER03-984-010

Dear Ms. Salas:

In its Order issued on October 6, 2006, the Commission referred the parties concerned with the Netting Bilaterals Project to the Commission's Dispute Resolution Service ("DRS") to facilitate a consensual resolution.¹ The October 6 Order directed the New York Independent System Operator, Inc. ("NYISO") "to file, on behalf of all involved parties, a report on the status of negotiations being facilitated by the Commission's DRS, within 45 days of the date of issuance of this order." In response to the October 6 Order, the NYISO respectfully submits this compliance report and has been authorized by Strategic Energy LLC ("Strategic"), the other party involved in the DRS-facilitated discussions, to state that it concurs with this compliance report.

Representatives of Strategic, DRS Staff, and the NYISO had an introductory meeting by teleconference on October 18, 2006 where DRS Staff provided background as to the dispute resolution process. On November 1, 2006, the parties met in-person at the Commission to continue discussions. In addition to those meetings, ADR Staff has had separate discussions with NYISO and Strategic. The parties are making progress in their discussions and are scheduled to meet in-person at the NYISO's facility in Rensselaer, NY on December 5, 2006.
