

**1st Quarter 2020** –The status of OATT 3.7 and OATT 4.5 System Impact Study requests, Transmission Service Study requests and Network Integration Transmission Service Study requests (collectively “Study Requests”) in the NYISO Queue during the 1<sup>st</sup> quarter of 2020 is summarized in the table below.<sup>1</sup>

The NYISO’s Open Access Transmission Tariff (“OATT”) was revised (effective September 13, 2008) to clarify that studies voluntarily undertaken by customers are not subject to the *pro forma* OATT’s sixty day completion deadline.<sup>2</sup> In addition, the revised NYISO OATT requires the NYISO to tender draft Study agreements thirty days after the scope of the Study Request is approved by the stakeholder Operating Committee, rather than within thirty days of the receipt of a study request as under the *pro forma* OATT.

As shown in the table above, one System Impact Study (SIS) performed by the customer is in progress and one SIS performed by the NYISO is pending on customer’s response. During the quarter, no new study request was received and no study requests were withdrawn.

The NYISO is not aware of any new Facilities Study agreements being delivered or conducted by New York’s Transmission-Owning utilities during the quarter. Under the NYISO OATT, the Transmission Owners, not the NYISO, are responsible for Facilities Studies.
