

2nd Quarter 2009 –The status of System Impact Study (“SIS”) requests in the NYISO Queue during the 2nd quarter of 2009 is summarized in Table 1 below.

Note that the NYISO’s Open Access Transmission Tariff (“OATT”) has been revised (effective September 13, 2008) to clarify that studies voluntarily undertaken by customers are not subject to the *pro forma* OATT’s sixty day completion deadline. In addition, the revised NYISO OATT requires the NYISO to tender draft SIS agreements thirty days after the scope of the SIS is approved by the stakeholder Operating Committee, rather than within thirty days of the receipt of a study request as under the *pro forma* OATT.

As shown on Table 1, five SISs were in progress during the 2nd quarter 2009, all by the respective customer or their consultants. The NYISO received two new SIS requests during the quarter. SIS agreements were offered for the two new requests and for a previous request received in March 2009. All SIS agreements were offered before or within thirty days after Operating Committee approval of the respective SIS scopes. The previously pending SIS agreement has been executed. The two more recent agreements have not yet been executed. No other SIS agreements were required or delivered during the quarter. No SISs were completed during the quarter. No SIS requests were withdrawn during the quarter.

The NYISO is not aware of any new Facilities Study agreements being delivered or conducted by New York’s Transmission-Owning utilities during the quarter. Under the NYISO OATT, the Transmission Owners, not the NYISO, are responsible for Facilities Studies.
