2nd Quarter 2010 – The status of System Impact Study ("SIS") requests in the NYISO Queue during the 2nd quarter of 2010 is summarized in Table 1 below.

Note that the NYISO's Open Access Transmission Tariff ("OATT") was revised (effective September 13, 2008) to clarify that studies voluntarily undertaken by customers are not subject to the *pro forma* OATT's sixty day completion deadline. In addition, the revised NYISO OATT requires the NYISO to tender draft SIS agreements thirty days after the scope of the SIS is approved by the stakeholder Operating Committee, rather than within thirty days of the receipt of a study request as under the *pro forma* OATT.

As shown on Table 1, five SISs were in progress during the 2nd quarter 2010, all by the respective customer or their consultants. The NYISO did not receive any new SIS requests during the quarter. No SIS agreements were required to be offered during the quarter. No SIS agreements were executed or required to be executed during the quarter. No SISs were completed during the 2nd quarter. However, two draft SIS reports were submitted by the respective customers to the NYISO during the quarter and were under review by the NYISO and the affected Transmission Owners at the end of the quarter. No SIS requests were withdrawn during the quarter.

The NYISO is not aware of any new Facilities Study agreements being delivered or conducted by New York's Transmission-Owning utilities during the quarter. Under the NYISO OATT, the Transmission Owners, not the NYISO, are responsible for Facilities Studies.
