4th Quarter 2012 –The status of System Impact Study ("SIS") requests in the NYISO Queue during the 4th quarter of 2012 is summarized in Table 1 below.

Note that the NYISO's Open Access Transmission Tariff ("OATT") was revised (effective September 13, 2008) to clarify that studies voluntarily undertaken by customers are not subject to the *pro forma* OATT's sixty day completion deadline.² In addition, the revised NYISO OATT requires the NYISO to tender draft SIS agreements thirty days after the scope of the SIS is approved by the stakeholder Operating Committee, rather than within thirty days of the receipt of a study request as under the *pro forma* OATT.

As shown on Table 1, NYISO received one new SIS request in September and two new SIS requests during the 4th quarter. One SIS was completed during the quarter and one SIS request was withdrawn during the quarter. Five SISs were in progress at the end of the quarter, one by NYISO and four by the respective customer or their consultant. SIS agreements for two of the new SIS requests were pending approval of the respective study scopes. One SIS agreement was offered during the quarter and executed three days after the end of the quarter.

The NYISO is not aware of any new Facilities Study agreements being delivered or conducted by New York's Transmission-Owning utilities during the quarter. Under the NYISO OATT, the Transmission Owners, not the NYISO, are responsible for Facilities Studies.
