Footnotes:

Beginning with the settlement months scheduled to be invoiced in the month of November 2005, the NYISO will issue 2 invoices per month. Both invoices will then be netted by the NYISO Controller's Office to provide for a single bank transfer. Market Participants are instructed to perform such netting after issuance of the second invoice each month to determine the net balance either owed to the NYISO or due from the NYISO. If the net balance of the 2 invoices issued in a month results in a

1. payment due to the NYISO, Market Participants should provide for the transfer of such funds to the NYISO bank account on the date indicated in the "Due To NYISO" column of this table, which is the 1st business day after the 15th of the month. Conversely, if the net balance of the 2 invoices issued in a month indicates a net payment is due to the Market Participant from the NYISO, funds will be transferred to the Market Participant's account on the date indicated in the "Due From NYISO" column, which is the 1st business after the 19th of the month.

2. 24-Month Settlement Adjustment cycle months closed out

3. 12-Month Settlement Adjustment cycle months on schedule

Per proposed tariff language, no final bill challenge invoice would be required in August 2006; however, since the proposed tariff language specifies that closeouts will occur as soon

4. as possible, but no later than 2 months after the expiration of the Market Participants' challenge period, it is contemplated that some or all of the final bill closeouts commencing in or after August 2006 may occur one month ahead of this schedule.
