March 21 – ICAP Automated Market – Go Live Date

Application open for:

- **Market Participant Administrators to set up Users in their organizations.**
- **Users to set up their accounts.**

March 30 – First Automated Market System Activity

- **Application available for Market Participants to submit bids and offers for Summer 2006 Strip Auction (May through October 2006).**

Billing Detail Display – MP Concerns

- ◆ As part of the manual process, NYISO sends a spreadsheet to all MPs with billing details (auction type, month, location, awarded MW, \$\$)
- ◆ This spreadsheet will be discontinued with the introduction of ICAP Automated Market
- ◆ Equivalent billing detail will be available on 3 screens in the automated system (following 2 slides)
- ◆ At least one LSE has expressed concern that lack of a single detail report may be a problem for their auditors

Resolution

- ◆ NYISO will identify options for creating display/download functionality that provides the necessary billing detail in a single location
- ◆ NYISO will review our recommended option with BAWG prior to implementation of any changes
- ◆ A Users Group (both MPs and NYISO staff) will prioritize known defects and enhancements (including this one) – initial meeting to be held in April
- ◆ If Users Group so indicates, new functionality will be included in the first upgrade release to ICAP Automated Market
- ◆ Degree of effort will determine when the upgrade will be deployed later this year
