MINUTES OF THE MEETING

1. Introduction and Meeting Objectives and Chairman's Report

Mr. Brown called the special meeting to order at approximately 9:00 AM and welcomed the members of the Management Committee ("MC"). He noted that the MC would be acting on two issues. Meeting attendees at the Best Western conference room, and via telephone conference introduced themselves and identified their company affiliations.

2. Report from the BS&P; Presentation of Two Motions

Mr. Parmelee reported that feedback from the Management Committee ("MC") meeting of August 8, 2002 was considered by the Budget Standards & Performance Subcommittee ("BS&P"). He noted that the MC indicated a preference to defer collection of the FERC fee overcharge until the next fiscal year. The motion that was made, and seconded, that proposed to collect FERC fee shortfalls beginning in January, 2003.

Ms. McGarvey responded to a question from Mr. Nachmias by stating that the NYISO had filed with the FERC for a clarification of the amount of the fee charged. She also stated that the NYISO could support the motion.

Mr. Younger raised the concern that, for the period of January 1, 2002 through May 31, 2002, under-collections and over-collections should apply to loads only. A friendly amendment to the motion was accepted to formally address this concern.

Motion #1:

Motion to support the collection of Year 2002 FERC fee shortfalls, if any, over the course of 2003, effective with January 2003 bills, provided that any shortfall resulting from the under-recovery of FERC fees that should have been assessed from January 1st through May 31, 2002 shall be assessed to loads only beginning with the January 2003 bills to reflect the parties responsible for those fees at that time; and provided further that any surplus resulting from the over-recovery of FERC fees that were assessed from January 1, 2002 through May 31st 2002 shall be assessed to loads only beginning with the January 2003 bills for the same reason.

(Motion passed unanimously, by polling members for abstentions and objections)

Mr. Parmelee also made a motion regarding the impact of billable load on the collection of Schedule 1 fees. Mr. Younger questioned the need for adjusting the Schedule 1 rate when the magnitude of the shortfall could not be quantified. Ms. McGarvey commented that should a shortfall occur, the Schedule 1 rate would be adjusted at that time. Mr. Brown suggested that the committee wait until Ms. McGarvey's next report before taking any action. Mr. Parmelee's motion was not seconded.

Ms. Robinson indicated that a slide would be added to the monthly President's Report to address actual billable load compared to projected.

3. Proposal to Revise Collateral Requirement for Transmission Congestion Contracts

Mr. Wemple reported that the proposed TCC credit policy amendment had been discussed at the August 15, 2002 special conference call of the Business Issues Committee ("BIC"). He described how the amount of collateral would be the greater value calculated from clearing prices or congestion rent. He said it had been questioned whether three months was the correct metric to use in the congestion rent calculation, and that the BIC approved the policy under the condition that Board be requested to delay a filing until after the September Board meeting to allow the BIC to consider alternatives to the net congestion rent test.

Mr. Younger expressed his concern that other market participant are indirectly mitigating NYISO credit risk due to the fact that energy payments are held for approximately twenty days, and capacity payments are also held.

A discussion concerning the timing of the implementation of Part A and Part B was made moot when Mr. Desell reported that the need to post collateral for the next TCC auction would not be until the end of October, thereby allowing the implementation of both parts to coincide with the need to post collateral.

A friendly amendment was accepted to address bankruptcy issues related to netting Transmission Congestion Contracts.

Mr. Mager expressed his support of the motion, but noted his opposition to the motion if the NYISO determines that the implementation of Part A without the implementation of Part B would result in a material risk.

Motion #2:

Motion to approve the TCC Credit Policy Amendment as presented to the BIC on August 15, 2002 and request NYISO Board of Directors to delay tariff filing until the September Board of Directors meeting, allowing the Business Issues Committee to consider alternatives to the Net Congestion Rent Test. The NYISO will also pursue an ISDA type arrangement to address bankruptcy issues related to netting of an entity's TCC contracts within the TCC portfolio.

(Motion passed by a majority in favor by polling members for abstentions and objections)
