The document was posted with the ESPWG/TPAS meeting materials on Monday, February 20, 2017. Comments are requested by Monday, February 27, 2017 for consideration prior to a review of the redline document at the March 7, 2017 ESPWG.

Ms. Popa noted that the NYISO has provided a listing of the assumptions used for the 2016 Reliability Needs Assessment for stakeholder convenience as Attachment C of the CRP. In response to a stakeholder suggestion, the NYISO agreed to add a table comparing the CRP assumptions to the RNA assumptions for additional convenience.
