Management Committee

Motion #1:

The Management Committee (MC) approves the April 11, 2014 and May 28, 2014 meeting minutes.

Motion #2:

The Management Committee (MC) hereby approves revisions to Attachment K of the Market Services and Control Area Tariff (“MST”) to clarify the CTS-PJM credit requirement, as described in the presentation entitled “Clarification to CTS-PJM Credit Requirements”, at the June 26, 2014 MC meeting and recommends that the Board of Directors authorize the NYISO staff to file these under Section 205 of the Federal Power Act.

The Management Committee (“MC”) hereby recommends that the NYISO Board of Directors authorize the NYISO to file with the Federal Energy Regulatory Commission, pursuant to Section 205 of the Federal Power Act, proposed changes to the NYISO’s OATT
