Creation of Resource Adequacy Issues Task Force (RAITF)

- 2-2-06 FERC Order on National Grid (NG) IRM Complaint
 - Dismissed NG complaint without prejudice
 - Directed NG to pursue its issue within the NYSRC and NYISO stakeholder processes
 - Directed NYSRC and NYISO to file report on progress in addressing NG concerns within 90 days (May 3, 2006)
- 2-10-06 NYSRC Executive Committee (EC) Meeting
 - EC and NYISO representatives express support for creation of a joint task force to coordinate between NYSRC Installed Capacity Subcommittee (ICS) and NYISO ICAPWG
- 2-17-06 ICAPWG Meeting
 - Attended by ICS Chairman (Curt Dahl) and several ICS members
 - Both groups supported the creation of the RAITF

RAITF Composition and Scope

- RAITF to be co-chaired by ICS Chair and ICAPWG Chair
- Open to all NYSRC and NYISO stakeholders
- Intended to facilitate stakeholder discussion regarding, and assist preparation of, joint NYSRC-NYISO report to FERC (the "May 3 Report")
 - Activities of RAITF, if any, beyond May 3 still undetermined
- Will report monthly to both NYSRC and NYISO
 - Within NYISO, will report to both BIC and OC

March 1, 2006 RAITF Kick-Off Meeting

- Formally adopted task force name
- Discussed in detail draft scope of work developed by ICS and ICAPWG Chairs, with input from NG, for preparation of May 3 Report
- Discussed need to coordinate drafting and review of report with need for market participant voting in the NYISO BIC and OC committees and with EC approval
- Determined that schedule considerations dictate that a decision must be reached in April on
 - whether stakeholders support revising resource adequacy rules and procedures to address NG concern; and
 - if so, whether such revisions should take the form of:
 - revising the procedures used to develop the IRM and LCR ("Reliability Approach"); or
 - Revising how costs associated with procuring these requirements are allocated among LSEs

 will report to EC at its March 10, 2006 meeting
 on RAITF progress in crafting scope of work and
 developments at kick-off meeting
- Next meeting of RAITF to be held March 15, 2006
