### Motion #1

The Business Issues Committee (BIC) hereby recommends that the Management Committee (MC) approve revisions to the NYISO's tariffs to enhance the credit requirements for TCCs and Virtual Transactions in conjunction with the implementation of the automated Credit Management System, as more fully described in the presentation made to the BIC at the October 22, 2008 meeting.

### <u>Motion #3</u>:

The Business Issues Committee hereby recommends that the Management Committee approve revisions to the NYISO's Tariffs regarding a modification to the Day-Ahead Market scheduling process, as is more fully described in the presentation made to this BIC meeting on October 22, 2008. *Motion passed unanimously with abstentions.* 

### Motion #4:

The Business Issues Committee hereby recommends that the Management Committee approve the proposed changes to the calculation of the dispatch limits of the second pass of the Real-Time market to reduce the effect of resources deviating from ISO dispatch instructions, as is more fully conceptually presented in the presentation made to this BIC meeting on October 22, 2008 provided, however that the specific physical withholding provisions set forth in the presentation require additional review and are not part of the concept hereby approved and further provided that such review shall take place prior to discussion and action by the Management Committee.

The Business Issues Committee (BIC) hereby approves the revisions to Section 4 of the NYISO's Installed Capacity Manual as presented and modified at the October 22, 2008 BIC meeting.
