# New York Transco... Background

- NY Transco formed as LLC November 2014
  - Affiliates of investor-owned utilities
- Purpose to own and construct high voltage transmission facilities in New York
  - Generation retirements reliability contingency
  - Reduce congested interfaces in New York AC projects
- NY Transco ultimate result of responding to public policy concerns about
  - Aging transmission infrastructure
  - Lack of transmission investment in New York
  - Persistent transmission congestion

# New York Transco... Formula Rate

#### NY Transco made FERC Section 205 filing - December 2014

- Cost of service formula rate
- Transmission rate incentives
- Base ROE
- Cost allocation for project costs
- Approval for 3 TOTS projects and 2 AC projects

#### Resolution

- Settlement of all issues related to TOTS projects
- FERC approval received March 17

# New York Transco Formula Rate (continued)

- Rates designed to collect NY Transco's annual revenue requirements associated with the approved TOTS projects
- 2016 rates will be set to collect revenue requirement of \$25.7 million from June 1<sup>st</sup> December 31<sup>st</sup>
- Revenue requirements for 2016, will be allocated to the transmission districts as approved by the FERC

### New York Transco...

#### Formula Rate Protocols

- Annual revenue requirement projections will be available by September  $30^{th}$
- Revenue requirement projections will reflect changes in O&M expense, rate base, and capital structure but ROE will remain fixed for at least 3 years
- Projections will be posted on the NYISO internet website
- Annual revenue requirement projections will be subject to true-up and reconciliation
- True-ups and reconciliations will be made available on the NYISO internet website on or before June 30<sup>th</sup> each year

### New York Transco...

#### Formula Rate Protocols (continued)

- Annual revenue requirement projections shall be subject to review, challenge, true-up, refunds or surcharges, as provided for in the protocols
- NY Transco required to have NYISO post on its internet website time, date, and location of stakeholder meeting for interested parties to seek information and clarification
- Protocols provide for the procedures for parties to challenge the projections and NY Transco's responsibilities to resolve challenges
