NYISO Management Committee Meeting Minutes September 20, 2007 NYISO, 10 Krey Boulevard, Rensselaer, NY 10:00 a.m. to 11:30 a.m. Minutes of the Meeting

1. Introductions, and Meeting Objectives and Chairman's Report

Mr. Picardi (Coral Power) called the meeting to order at 10:17 AM and welcomed the members of the MC. The members of the MC then identified themselves.

2. Approval of Minutes

Mr. Ray Stalter (NYISO) presented for approval the MC minutes from the August 29, 2007 meeting. He reported that no comments were received on the minutes distributed for MC review prior to the meeting, and asked if members had any comments. No comments or questions were raised. The minutes were then approved.

Motion #1:

Motion to approve the Minutes of the August 29, 2007 MC meeting.

Motion passed unanimously.

3. President's Report.

Mr. Mark Lynch of the NYISO presented the President's Report. He began with the approval of the 2007 Comprehensive Reliability Plan by the Board of Directors on September 18, 2007, and noted a press release was issued on September 19, 2007. Mr. Lynch thanked MPs for their efforts to complete the CRP. Mr. Lynch also provided a status update on the 2008 CRPP, noting the initial draft RNA report is scheduled for discussion at the October 4, 2007 ESPWG/TPAS meeting.

Mr. Lynch noted the draft FERC Order 890 filing was posted on September 14, 2007. Mr. Lynch also explained the importance of MP participation in the October FERC Technical Conference. Mr. Howard Fromer (PSEG) commented that, within the past week, a major settlement was filed at FERC by PJM addressing many of the issues related to Cost Allocation. He explained the settlement before FERC defers resolving that issue for a year, and asked whether the NYISO would support advising FERC that more time would be helpful. Mr. Lynch replied the NYISO will review the settlement documents, but as of today, there were no plans to change the schedule for the filing.

As for the Price Correction Statistics, Mr. Lynch noted that August had eight price reservations and five price corrections. Through September 13, there were two reservations and two corrections. He added that, while dramatic improvements have been made over the last four months, the NYISO needs to continue to demonstrate this success, and is on a good path.

Mr. Lynch addressed the Repayment of Working Capital for TCC Settlement Issue; he noted the full recovery of the Working Capitol will be achieved in the 1st quarter of 2008.

Mr. Lynch noted a few items from the September 16, 2007 Board meeting; the BOD approved the CRP, the ADR Mechanism and the Working Capital Tariff Filings approved at the last MC meeting. No other action items for bill challenges were taken by the Board. Mr. Paul Gioia (LeBoeuf) asked when the NYISO will make changes to the Strategic Plan. Mr. Lynch replied the NYSO will present the Strategic Plan at a later MC meeting, and there are no plans to change it.

Doreen Saia (Mirant) asked if the NYISO could provide a spreadsheet at the next MIWG with the breakout of the elimination of the TCC settlement surcharge. Mr. Lynch replied it's on the NYISO's website, and will be brought to the MIWG.

Mr. Fernandez (NYISO) noted that while Mr. Berle is out, Mr. Grossi will chair the Board Governance committee. He added that the Board will continue to function as normal.

4. NYISO 2008 Budget Overview

Mr. Stuart Nachmias (Con Ed) stated the BPWG reviewed the draft 2008 budget at its September meeting. He stated it is important to note that the Rate Schedule 1 charge is within the budget target established in 2003, and is a reduction from the 2007 rate. BPWG appreciates that NYISO is sticking by the rate committed during 2003. Mr. Nachmias noted the NYISO is adding 22 staff members in 4 different areas; Planning, IT, Market Services and Market Monitoring. These additions will result in a large increase in the area of salaries and benefits.

Mr. Nachmias explained the 2008 proposed budget is consistent with 2007 current year needs; and there will be a decrease in debt service as a result of the rolling off of financing costs of SMD2. Any budget under-runs will be used to reduce financing for the NYISO. He also noted the NYISO has a higher Rate Schedule 1 than other ISOs/RTOs although NYISO has a lower revenue requirement, but that could be due to NYISO operating as a single state ISO. BPWG will continue to review NYISO rates.

Mr. Nachmias asked the Management Committee Members for comments. Mr. Gioia noted the language on the schedule should read "review and approval." Mr. Fromer (PSEG) complemented Mr. Nachmias and the BPWG on the presentation and their hard work, but raised a concern with budget allotments on certain projects and the level of commitment for projects without MP input. Mr. Nachmias replied the issue was addressed at the BPWG, and noted some projects are multi-year, some are new and have been discussed in the working groups, and others have not been discussed, but are anticipated because of FERC activities. The proposed projects represent the NYISO's recommendations for the most valuable projects for the coming year, as well as the best estimate of anticipated regulatory requirements. As business priorities or regulatory requirements change during the year, the BPWG will get involved in a re-prioritization of budget. Mr. Fromer replied that as we move from the 1st draft to the final draft of the budget, MPs need an opportunity to identify potential projects for inclusion. Mr. Nachmias noted it is critical for MPs to review the 2008 Projects list and send comments to him and Ray Stalter (NYISO). Mr. Younger (Slater Consulting) asked if the NYISO will provide an update on the placeholder allocation for market enhancement projects at the October 1 MIWG meeting. Mr. Dewey (NYISO) replied that the intent is to have discussions on each project in the placeholder allocation. Mr. Younger expressed concern with the pace of the projects in the placeholder. Mr. Nachmias explained that the money indicated in the budget would only be used on external resources; internal resources are not included.

Mr. Rich Dewey (NYISO) presented the proposed 2008 project plan. He noted the process for selecting projects for 2008 included identifying cornerstone Product Plan items, the continuation of multi-year programs, regulatory requirements and necessary infrastructure enhancements. Mr. Dewey explained the detailed cost estimates for the proposed projects was performed following a prioritization of candidate projects based on MP comments and feasibility analysis based on a review of internal resources. Project and budget updates are conducted at each BPWG meeting. Mr. Dewey reviewed the list by product line, noting the expected expenditures for professional fees.

Mr. Fromer asked if the \$3.4 million noted for Energy Market Products included all of the projects listed. Mr. Dewey explained the six projects (Enhanced Price Validation - Phase 3, Comprehensive Bid Management - Phase 3, Wind Forecasting System, Market Monitoring System Enhancements, Market Software Re-certification and Priority Market Enhancements) encompass the \$3.4 million. The seven projects at the bottom of the slide (Scheduling and Pricing Improvements, Netting of Bilaterals, Disaggregated Virtual Trading, Reference Price System Enhancements, Inter-ISO Congestion Management, Ancillary Service Market Convergence, and Other Market Enhancements Under Review) are a subset of the proposed project set. The NYISO feels that, based on a resource assessment, it is likely that about three of those projects can be accomplished. The ability to complete such projects is not gated by finances; but rather by availability of internal resources. Mr. Fromer replied that there should be MP input on which of those projects would be accomplished. Mr. Younger added that the NYISO needs to explain this new concept. Mr. Gioia stated that this discussion should be held at the BPWG. Mr. Nachmias added that the scope of the projects listed is still being worked out at the working group level. Mr. Dewey noted the NYISO has not specified which projects will be done, because that has yet to be worked out with MPs, there is a lot of testing, analysis and review to be completed as well as being brought through the Governance process. Mr. Nachmias added that this discussion will occur at the October 2nd BPWG meeting. Mr. Younger requested the NYISO provide a detailed presentation at the MIWG meeting. Mr. Picardi (Coral Power) noted the MIWG meeting will be important, and asked that issues from the meeting be clearly defined prior to the October MC meeting.

Mr. Nachmias reviewed the 2009-2012 budget targets. He stated there are currently no commitments in place for 2009 – 2012, and it is the intention of the NYISO to approve budgets annually. Updated budget projections for the subsequent four years will also be provided along with each year's proposed budget. Mr. Nachmias added the issue will be addressed at the October 2 BPWG meeting, and he is looking for MP input on how to convey budget principles and overall objectives to the MC, and the NYISO Board. Mr. Picardi asked if the discussion of principles will be ongoing, and Mr. Nachmias replied that it will be. He added that the budget motion that will be brought to the MC in October for a vote will not include reference to future budget year projections, and 2008 is the last year within the firm targets established in 2003. Mr. Gioia asked if there has been consideration for another five-year plan. Mr. Nachmias replied that the NYISO has stated they would not preclude that. Mr. Lynch added that this discussion would be better suited for the incoming CEO. Mr. Stalter requested that MPs send comments/questions to rstalter@nyiso.com.

5. New Business

Mr. Stalter reminded the MC that the October 24 meeting will be held at Con Edison's 4 Irving Place offices.

6. Adjournment

Meeting adjourned at 11:30 AM.
