STATUS REPORT TO THE PRESIDING ADMINISTRATIVE LAW JUDGE

In compliance with Paragraph D of Presiding Administrative Law Judge Benkin's January 24, 2005 *Order Establishing Procedures* ("Order"), the Consolidated Edison Company of New York, Inc., New York Independent System Operator, Inc., PJM Interconnection, L.L.C., and Public Service Electric and Gas Company (together, the "Parties") respectfully submit this status report.

It appears that the Parties will probably not be in a position to make the required joint compliance filing by February 15, 2005. On the other hand, the Parties fully expect to make the filing shortly after that date, and no later than February 18, 2005. The Parties therefore respectfully request permission to make the joint compliance filing by February 18.

There may still be disputed issues at the time that the compliance filing is made. To the extent that such issues exist they will be described in a joint stipulation, as required by Paragraph C of the Order.
