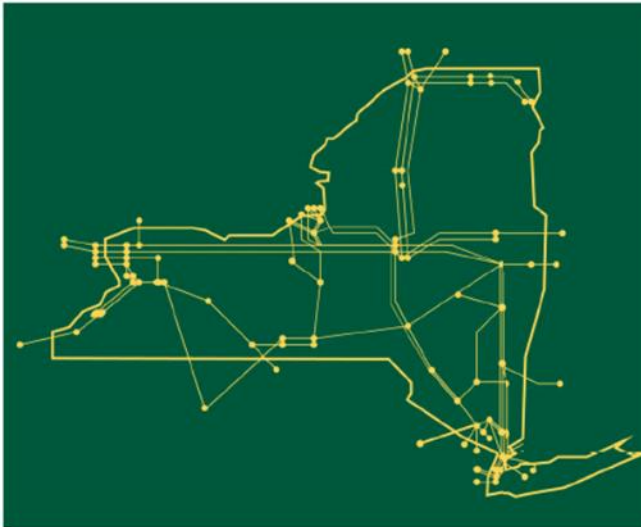

 - *All DSASP Resource Registrations will require a DRIS Resource Report*
 - *DRIS Resource Submittals generated in error must be canceled by contacting NYISO Stakeholder Services (518-356-6060)*
