
Prerequisites to DSASP Resource Enrollment

- ◆ Prior to importing DSASP resources into DRIS, Market Participants must have completed the following:
 - ***Contact Member Relations***
 - Register as a NYISO Customer
 - Register as a DSASP Provider
 - ***MIS***
 - Have DRIS user privileges assigned by the MP organization MIS Administrator
 - ***DRIS***
 - Assign a contact type of “Admin” for DSASP in DRIS



The NYISO has four Demand Response programs: the Emergency Demand Response Program (EDRP), the ICAP Special Case Resources (SCR) program, the Day Ahead Demand Response Program (DADR) and the Demand Side Ancillary Services Program (DSASP).

Both the EDRP and SCR program can be deployed in energy shortage situations to maintain the reliability of the bulk power grid. Both programs are designed to reduce power usage through shutting down of businesses and large power users. Companies, mostly industrial and commercial, sign up to take part in the programs. The companies are paid by the NYISO for reducing energy consumption when asked to do so by the NYISO. Reductions are voluntary for EDRP participants. SCR participants are required to reduce power usage and as part of their agreement are paid in advance for agreeing to cut power usage upon request.

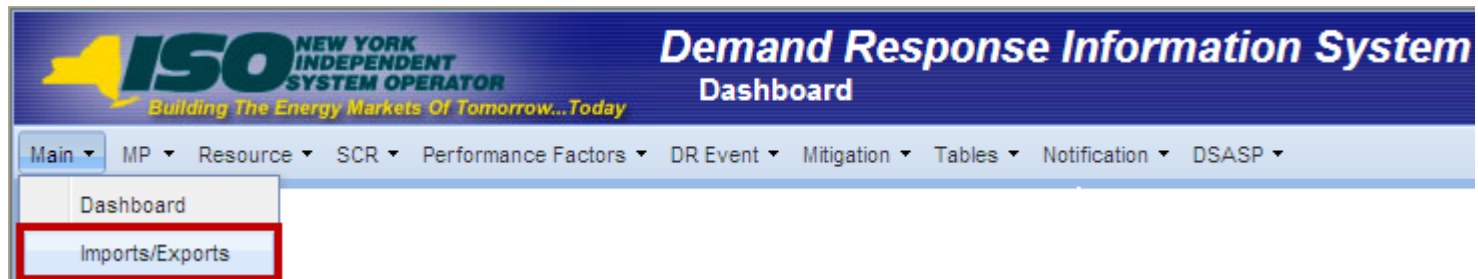
The NYISO's Day-Ahead Demand Response Program (DADR) allows energy users to bid their load reductions, or "negawatts", into the Day-Ahead energy market as generators do. Offers determined to be economic are paid at the market clearing price. DADR allows flexible loads to effectively increase the amount of supply in the market and moderate prices.

The Demand Side Ancillary Services Program (DSASP) provides retail customers that can meet telemetry and other qualification requirements with an opportunity to bid their load curtailment capability into the DAM and/or Real-Time Market to provide Operating Reserves and regulation service. Scheduled offers are paid the appropriate marketing clearing price for reserves and/or regulation.



DSASP Resource Enrollment Data – New Data Defined

◆ DSASP Authorization

- *Format: Must be Y or N*
- *Acknowledgement of agreement between individual resource and Market Participant*

◆ Aggregation Type

- *Format: Must be 1, 2, 3 or 4*
- *Aggregation Type corresponds to aggregation resource count and Market Product*

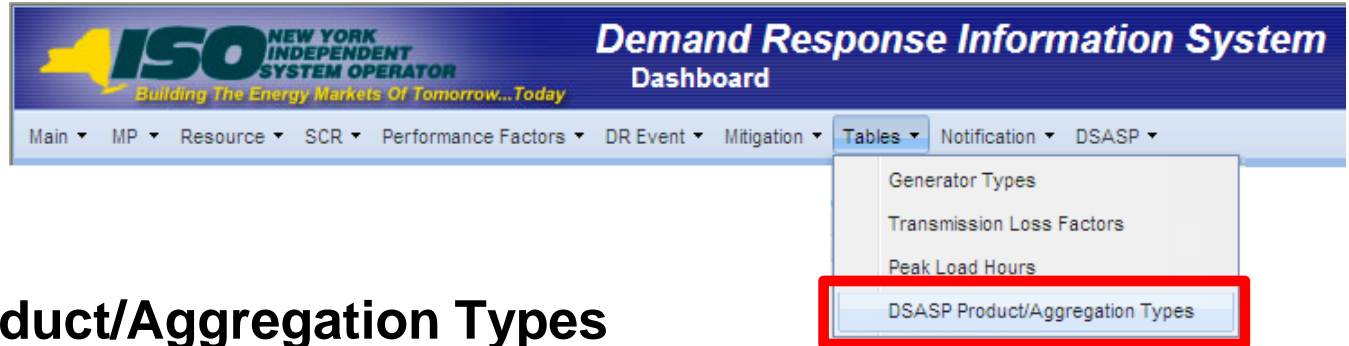
DSASP Resource Enrollment Data – Eligibility by Response Type

- ◆ **DSASP Response Type and Product Mix**
 - *Dependent on Response Type of a resource*
 - *Resources which meet criteria may participate in allowed product types either individually or as part of a group*
 - *Type C Resources may participate in all three product categories*
 - **Spinning, Non-Synchronous, Regulation**
 - *Type B and Type G Resources may only participate in the Non-Synchronous product category*

DSASP Resource Enrollment Data – Market Products

- ◆ **Spinning**
 - *Format: Y or N, if Y, other product categories must be labeled N*
- ◆ **Spinning & Regulation**
 - *Format: Y or N, if Y, other product categories must be labeled N*
 - *NPCC A-06 “Operating Reserve Criteria” was approved on 7/17/2007 to reflect:*
 - **Interruptible load eligible for synchronous reserve**
 - **Behind the fence generation eligible for non-synchronous reserve**
 - **No DSASP Resource connected to behind the meter generation of any kind is eligible for Spinning Reserves or Regulation**
- ◆ **Non-Sync**
 - *Format: Y or N, if Y, other product categories must be labeled N*
 - *Curtailment and/or eligible behind-the-meter Local Generator as demand response (Response Types B, C or G)*

DSASP Resource Enrollment Data – Load and Generation

- ◆ **Summer & Winter Subscribed Load kW**
 - *Format: Numeric, kW*
 - *Values based on Response Type:*
 - **B: Must be greater than or equal to zero**
 - **C: Must be greater than zero**
 - **G: Must be null or zero**

- ◆ **Summer & Winter Subscribed Gen kW**
 - *Format: Numeric, kW*
 - *Values based on Response Type:*
 - **B: Must be greater than zero, no greater than Name Plate Rating**
 - **C: Must be null or zero**
 - **G: Must be greater than zero, no greater than Name Plate Rating**

DSASP Resource Enrollment Data – Load and Generation

- ◆ **Summer & Winter Subscribed Load and Subscribed Generation kW**
 - *Validation of an individual Demand Side Resource into DRIS does not require values for both Capability Periods*
 - *Qualification of the Aggregate DSASP Resource requires greater than 1 MW of reduction capability for BOTH seasons*

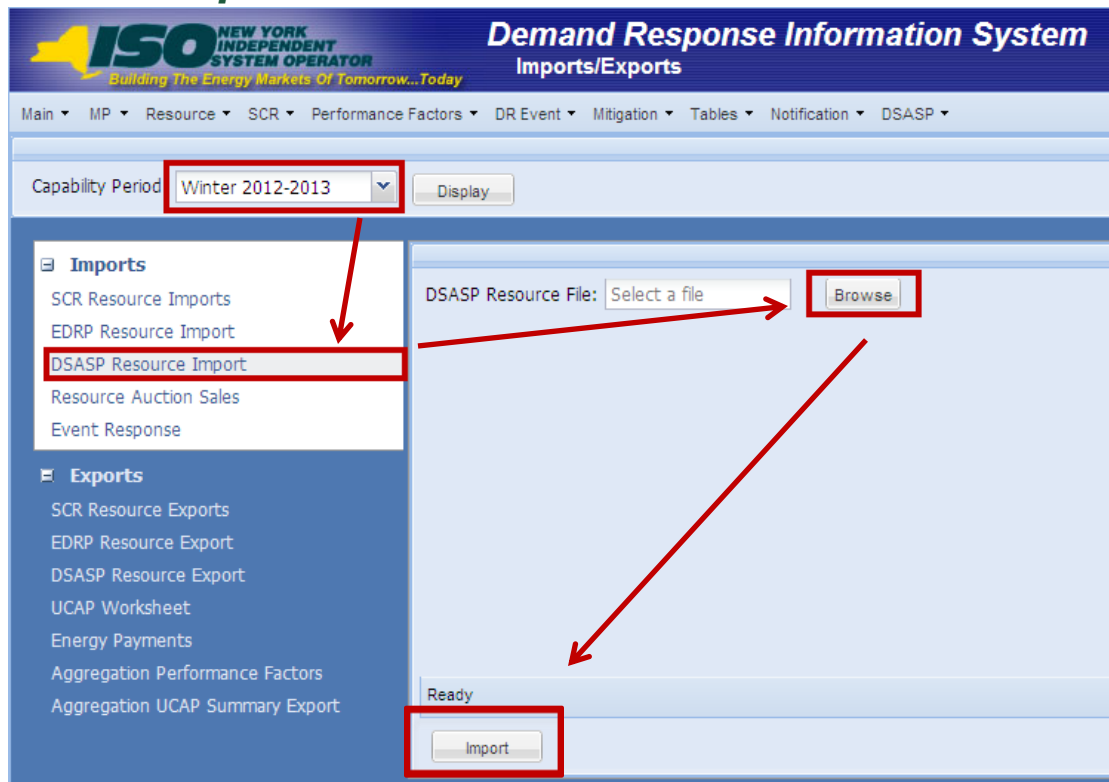
DSASP Resource Enrollment Data – Communication Type

◆ Direct Communication

- *Format: Y or N*
- *Represents the communication path of Resource/Aggregator with the NYISO*
- *Y = Direct Communication with NYISO*
- *N = Communication with NYISO through Transmission Owner*
- *Must have same response for all resources within same aggregation*

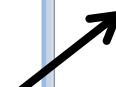


