# Prerequisites to DSASP Resource Registration with MIS

- Prior to registering DSASP Resources with NYISO Member Relations, Market Participants must have completed the following:
  - Export DRIS DSASP Resource Report



## **DSASP Resource Management**

From the DSASP Menu select Aggregation Management



- "Select" resources to include them in the aggregation
- "De-select" resources to remove from aggregation



- Select "Submit"
  - Include export of DSASP Resource Report with the NYISO Demand Side Ancillary Service Program (DSASP) Resource Registration Packet

### **DSASP Resource Report**

- Successful validation of the DSASP Aggregation in DRIS produces the "DRIS DSASP Resource Report"
  - Report is exported as a read-only Excel file
  - Report size and number of pages will be dependent upon the number of Demand Side Resource(s) within a DSASP Resource/Aggregation
    - Three possible sections
    - Minimum number of pages is two
    - Maximum is defined by DSR count in Aggregation



### **DSASP Resource Report**

- Submittal ID
  - Unique value assigned to each Submittal performed for an Aggregation
    - Automatically assigned by DRIS
    - Represents both the Aggregation and the individual resources during the Submittal phase
    - Used for tracking and identification of aggregation registration paperwork for MIS
    - Required for requesting a cancellation



### **DSASP Resource Report**

- DRIS Demand Side Resource (DSR) Enrollment Status of Submitted
  - Represents a DSR in the process of becoming Qualified for participation in the market
    - A DSR cannot be updated while in the Submitted state
    - A DSR must become Qualified or the Submitted aggregation must be canceled by the NYISO before actions may be taken to change individual DSR values or manage the Submitted aggregation
    - Only one active submission may exist for an aggregation
    - Submissions made in error will need to be canceled by NYISO Stakeholder Services
      - To cancel a submittal, contact Stakeholder Services at 518-356-6060



# DSASP Resource Report Contains three possible sections:

- - Section 1: DSASP Aggregation Submittal Report
    - **Aggregation and Submittal IDs**
    - Resource values for those being added or updated for the aggregation
    - MW calculations
    - Signature and date fields for DSASP Provider to complete
  - Section 2: DSASP Resource Type, Bid Privileges and Unit Commitment Parameters
    - Aggregation and Submittal IDs
    - Fields for Product Type, Aggregation Type (Group or Individual), **Generator Limits and Bid Flags**
    - Signature and date fields for DSASP Provider to complete
  - Section 3\*: Demand-Side Resource Removal Summary
    - Aggregation and Submittal IDs
    - DSR values for resources being removed from the aggregation

\*Section 3 will be blank when no DSRs are being removed from the DSASP Resource. Section 3 is for MP records only, not required by the NYISO.



### **DSASP Resource Report Section 1**

- DSASP Aggregation Submittal Report Data
  - Populated by DRIS
    - Submittal ID
      - Numeric value which changes with each Submittal
    - DSASP Agg ID
      - Numeric value which is constant for the Aggregation
    - Generator PTID
      - Numeric value which will not be included on the first submission. Any subsequent submissions after registration has been completed will contain this value from DRIS
    - DRIS Resource ID
    - Resource Name
    - Zip Code
    - TO Account #
    - Seasonal Total MWs
      - Seasonal MWs for the specific Submittal
    - Change From Inception
      - Change in Seasonal MWs since first Submittal
    - Change From Last
      - Change in Seasonal MWs last Submittal



# **DSASP Resource Registration**

- Combined DSASP Resource Registration Documents:
  - Sent to NYISO by Market Participant
  - MPs will be contacted by NYISO Stakeholder Services once registration is validated
  - During Submission Process
    - Cannot update DSRs included in the active Submission for the aggregation
    - Cannot generate a new Submission for the aggregation
- Option to Cancel Submission
  - Contact NYISO Stakeholder Services to cancel the active Submission for the aggregation
- Submittal ID will be end-dated in DRIS when the DSASP Resource has passed pre-qualification test
  - All associated DSRs of the DSASP Resource will have an Enrollment Status of Qualified



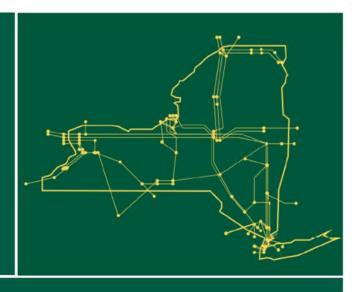
### **Submittals for DSASP Registration**

- First Submission of the Aggregation
  - Include Sections 1 and 2 of the DRIS DSASP Resource Report with the DSASP Resource Registration Packet sent to Member Relations
- Subsequent Submissions of the Aggregation
  - Send only Sections 1 and 2 of the DRIS DSASP Resource Report to Member Relations on all subsequent updates to an aggregation
- Types of updates requiring a submittal include:
  - Addition/Removal of resources from the DSASP Resource
  - Changes to resource MW values

Form should be sent to NYISO's Member Relations
