- Submittal Action field values
 - Add
 - When a Qualified record does not exist for the resource
 - Update
 - When a Qualified record exists for the resource and a field has been modified
 - No Change
 - When a Qualified record exists for the resource and there are no field changes
 - Remove
 - When a Qualified record exists for the resource, and it has been selected for removal from the aggregation
 - Separated
 - When the resource has been separated from the MP
