The Commission has directed the NYISO to file service agreements for the Member Systems of the New York Power Pool ("Member Systems") within 30 days from the date the NYISO commences operations. Service Agreements for the Member Systems are included herein.

Effective Date, Request for Waiver and Request for One-Day Extension of Time

Except as otherwise noted, the effective date for each Service Agreement is November 18, 1999, the date on Attachments I, II and III which the NYISO commenced operations under the ISO OATT and under the ISO Services Tariff. Pursuant to Section 35.11 of the Commission's rules and regulations (18 C.F.R. § 35.11), NYISO requests a waiver of the Commission's notice requirements (18 C.F.R. § 35.3). Under *Prior Notice Filing Requirements Under Part II of the Federal Power Act*, 64 FERC ¶ 61,139 at 61,983-84 (1993), waiver would have been appropriate if the service agreements had been filed yesterday. The delay in filing was occasioned by a number of factors. The effective date was not known with certainty until the NYISO actually commenced operations and successfully completed its initial operating period as of December 1, 1999. Compiling and copying a complete set of Service Agreements took longer than anticipated. In addition, a single filing of a large group of Service Agreements accepted to date promotes administrative efficiency both for the Commission and the NYISO and could not be done until the NYISO had an opportunity to process the Service Agreements. In the circumstances, the waiver of the Commission's notice is required and the filing of Service Agreements for the Member Systems should be accepted one day out of time.
