NYISO Management Committee Meeting Minutes

Sheraton Syracuse University Hotel & Conference Center 801 University Avenue, Syracuse, NY 13210

I. Introductions, Meeting Objectives, and Chairman's Report

Joe Oates, Chair of the Management Committee (MC), called the meeting to order at 10:05 A.M. and welcomed the members of the MC. The attendees introduced themselves and named the companies that they represent.

Rob Fernandez, General Counsel of the NYISO, reminded the Committee Members that a Vice Chair vacancy exists and the MC has the opportunity to elect a new Vice Chair. Otherwise, NYISO CEO and President, Bill Museler, will appoint someone to this role from the NYISO management team. An August or September election for the new Vice Chair is anticipated.

Elaine Robinson, MC Committee Liaison, informed the Committee Members that their concurrence of the nominating committee members is needed.

Next year's MC meetings are planned for the first Wednesday of each month in either Albany or NYC. Also, the casual dress policy for market participants has been extended to year-round.

Steve Jeremko, of NYSEG, suggested changing the November 2003 MC meeting for considering the 2004 Budget so that it occurs prior to the Board's vote to finalize the budget. Mr. Oates and NYISO staff agreed to look into this possibility.

Mr. Oates also noted that no significant changes have been made recently to the Project Prioritization Team's (PPT) project list.

II. President's Report

Bill Museler reported on reliability indicators, market performance highlights, the NAESB seams meeting, Board Guiding Principles, SMD, and 12-Month Final Bills. He also announced that FERC would hold an SMD Technical Conference in New York.

Mr. Museler noted that, in the future, he would include graphs in the Market Performance Highlights portion of his presentation that are more legible when printed out in black and white. In response to an inquiry from Howard Fromer, of PSEG, Mr. Museler stated that the increase in OOMs and SREs in early July has been reversed and that there would be a report on the causes at the next meeting.

Mr. Museler reported that a NAESB Seams Subcommittee is being formed to look at the issue

beyond the Northeast.

The FERC SMD conference on New York is scheduled for October 20, 2003 in Albany, the day before the joint MC/Board meeting. Mr. Oates and NYISO staff will look into the possibility of scheduling the two meetings in the same location and reschedule the MC meeting originally scheduled on that day.

Howard Fromer, of PSEG, asked Mr. Museler to share his understanding of the significance of NAESB adopting a definition and resolution of a seams issue. Mr. Museler stated that it makes sense to have a standard definition and that NAESB operates through "standards" which need to be approved by their executive committee. He also noted that during the approval process, the NYISO Market Participant's, via the existing governance process, have an opportunity to present their position as well.

In reference to the "Guiding Principles – Mitigation of Market Participant Loss" document, Neil Butterklee, of Con Ed, asked for clarification as to what action the NYISO should be taking. Mr. Museler replied that the guiding principles were written in a general sense, and not in a step-by-step list, so that they wouldn't be too prescriptive.

Ray Kinney suggested that the "Guiding Principles" should more clearly state that the Tariff is the minimum standard to abide by for credit requirements. Mr. Museler noted that he would take this suggestion back to the NYISO Finance Department.

III. Meeting Minutes

Because some suggested changes to the minutes were not received ahead of time, approval of the minutes was deferred until next month.

IV. Update on Seams and Market Improvement Projects

Chuck King presented the Committee Members with an update on the Northeast Seams Issues. He reviewed the list of current quarter deliverables, recent initiatives, and open issues.

Mike Mager, of Couch White, noted that ISO-NE's Rate Pancaking elimination proposal differs from the NYISO's in several ways. He asked Mr. King what he sees as similarities between the two markets' approaches. Mr. King responded that both types of proposals have reciprocity requirements.

Jim Scheiderich, of the NYISO, noted that the paper on Virtual Regional Dispatch (VRD) that was sent to the Market Structures Working Group (MSWG) shows how VRD solves the "symptom" but not the underlying problem. Mr. King noted that they would allocate time at the joint VRD meetings to discuss these issues. Mr. Museler added that alternatives to the current VRD proposal should be explored since the NYISO has no intention of filing something that doesn't receive market participant approval.

He also announced that the NYISO has released a Technical Bulletin on Web-based Reconciliation.

Mr. King reported on the July 8th North American Inter-RTO Seams meeting. He noted that participation was good and that the topics discussed included: seams issues and resolution processes, coordination between JIC, NAESB, and NERC, and the formation of a North American Inter-RTO Working Group. Howard Fromer, of PSEG, asked if minutes from this meeting were available. Mr. King noted that the group had not kept official minutes but will consider doing so for future sessions. Stephen Wemple, of Con Ed Solutions, asked Mr. King to comment on whether they've found that common problems exist all across the region. Mr. King noted that the problems in the West are very different than those in the Northeast because of the way their system is structured.

Finally, Mr. King addressed Market Participant involvement in RTS Tariff Development. He said that Market Participants would have an opportunity to review the proposed tariff language at the upcoming Market Structures Working Group (MSWG.

V. Report and Motion from the BS&P Subcommittee

Jim Parmelee, of LIPA, presented the Budget Development and Project Monitoring Guidelines developed by the BS&P Subcommittee and NYISO staff. He gave an overview of some aspects of the guidelines, discussed the transition, gave an overview of By-Law Changes, and reviewed the BS&P motion.

Neil Butterklee asked if approved increases in projects automatically increase the NYISO budget. Mr. Museler responded that any increase in the NYISO's budget requires Board authorization.

Jim Scheiderich expressed a concern about eliminating the process of having the BIC review of market rules. Mr. Parmelee replied that the proposed process is not designed to change any current processes – specifically the process of having items go through the BIC for their review.

Tariq Niazi, of the NYS Consumer Protection Board, noted two exceptions in the proposal that don't require Management Committee vote. He asked if they would still be communicated. Mr. Parmelee replied that they would be reported to the BS&P and monitored.

Mr. Parmelee moved the motion and Steve Wemple seconded it. Two friendly amendments were added to the motion.

The motion passed by a show of hands. The following parties abstained from voting: Select Energy, Dynegy, NRG Power Marketing, and KeySpan Ravenswood.

VI. Report and Proposed Amendments from By-Laws Committee

A By-Laws and Governance Subcommittee Summary of Key Proposed Revisions to the Management Committee By-Laws

Neil Butterklee presented proposed changes to the MC By-Laws.

Wes Yeomans, of National Grid, noted that it might be problematic to require a five-business-day notification for agenda items of Special Meetings.

Tim Bush, of Navigant Consulting, noted his concern with scheduling special meetings because some Market Participants have limited staff and that should be taken into consideration. Mr. Butterklee noted that special meetings are scheduled at the discretion of the Chair.

Mr. Butterklee moved the motion and Mike Mager seconded it.

By a show of hands, the motion passed. KeySpan Ravenswood abstained from voting.

B. Proposed Revisions to Article II of the MC By-Laws

Mr. Butterklee presented proposed revisions to Article II of the MC By-Laws regarding procedures for becoming a voting member and designating a different or alternate representative.

Mr. Scheiderich noted that there seems to be an issue with timing/wording in the Tariff as to what entities could or couldn't be approved as a Market Participant. Mr. Butterklee noted that various definitions of Market Participants exist and that the NYISO would be responsible for making sure an entity fits into one of the defined categories. Mr. King added that Customer Relations has procedures in place for approving entities. Mr. Butterklee added that other Market Participants would like to have an opportunity to say if a customer doesn't fit in as a potential Market Participant.

Mr. Butterklee moved the original motion with the amendments (that were approved in Section VI, Part C of this set of meeting minutes) and Mr. Fromer seconded it.

Three parties voted against this motion. and NYSERDA, Aquila, and Strategic Power Management abstained. The amended motion passed by a majority show of hands.

C. LIPA's By-Law Proposal Motion Amendment 10-Day Membership Process

Jim Parmelee presented an amendment to the By-Law Proposal Motion to extend the new member acceptance process to 10-Days.

Doreen Saia, of Couch White, noted her concern that enough time be allocated to discuss whether MP clients have any issues with potential members. Mr. Mager noted that by unnecessarily extending this time period, it delays potential parties from voting. He added that the NYISO has had no history of controversial or illegitimate applicants; therefore, he supports the original proposal.

Mr. Scheiderich moved the original motion and Mr. Butterklee seconded it.

Mr. Parmelee moved the motion to amend and Doreen Saia seconded it.

By a roll call, the motion to amend passed.

D. Proposed Revision to Article IV of the MC By-Laws

Mr. Butterklee presented a proposed revision to Article IV of the MC By-Laws that would enable the MC Chair, at his discretion, to convert a regular MC meeting to a conference call.

Mr. Oates asked how this revision differs from the current process. Mr. Butterklee explained that this revision states some criteria such as when the MC Chair is able to convert the meeting to a conference call. Garry Brown, of the NYISO, stated that the chair doesn't always know what's included on the agenda before five business days; therefore, a three or five business day makes no difference.

Mr. Butterklee moved the motion. A friendly amendment was made to the proposed section 4.17 to read "at least three days in advance." Two parties abstained from voting. The motion was approved by show of hands.
