Notice of Class Year 2021 Second Round Security Posting Default – Initiation of Third Round

Dear Class Year 2021 Project Developers:

On December 15, 2022, a notice was sent informing you of the results of the Class Year 2021 Second Round and requesting payment or the posting of Security by December 21, 2022 for your respective Project Cost Allocations and Headroom obligations, as applicable.

This is to inform you that Security Posting Defaults have occurred, and therefore, the NYISO must update the Class Year 2021 Study results for the remaining Class Year Projects, initiating another decision round. As a result, Class Year 2021 has not completed, and <u>Class Year 2023</u> will commence no earlier than February 13, 2023.

With respect to payments made and Security posted the Second Round, please note the following from Section 25.8.2.2 of Attachment S to the NYISO OATT:

- Upon request by a Class Year Developer, beneficiaries of the payments and Security posted by the Developers that did pay or post Security "shall surrender the cash and posted Security to the respective Developers immediately."
- Beneficiaries of the payments and Security posted by the Developers in the Second Round shall not make any draws or encumbrances on any cash or posted Security unless and until cash has been paid and Security has been posted by all Developers that issued Acceptance Notices in the Final Decision Round."

Initiation of Third Round for Class Year 2021

The NYISO will issue a revised Class Year 2021 Study report, including Revised Project Cost Allocations for SUFs, SDUs and Deliverable MWs, as applicable, by January 4, 2023, in accordance with Attachment S of the NYISO OATT.

Once the NYISO issues the revised Class Year 2021 Study report, the NYISO will issue one of the following notices:

- Notice initiating a seven (7) calendar day decision period for the remaining Class Year 2021 Project Developers with increased Project Cost Allocations or decreased Deliverable MWs; or
- Notice triggering the requirement to make payment or post Security within five (5) Business Days from the end of the Decision Period (*e.g.*, if the Revised Report is issued January 4, 2023 and there are no increased Project Cost Allocation or decreased Deliverable MW, the payment/Security posting deadline will be January 11, 2023).

If any remaining Class Year 2021 Project Developers reject a Revised Cost Allocation or Deliverable MW in the Third Round or if a Security Posting Default occurs at the end of the Third Round, the NYISO will initiate a Fourth Round and prepare and issue another revised Class Year Facilities Study with Revised Project Cost Allocations and Deliverable MWs, as applicable.
