## Notice of Initial Decision Period Results to Class Year 2021Additional SDU Study Projects – Initiation of Second Round

## Dear Developers:

This is to inform you that a Non-Acceptance Event has occurred in the Initial Decision Period for the Class Year 2021Additional SDU Study ("CY21 ASDU Study"), and therefore, a Subsequent Decision Period will be required. Developer decisions from the Initial Decision Round are summarized in the Table 1.

The NYISO will issue a revised CY21 ASDU Study report, including Revised Project Cost Allocations for SUFs, SDUs and Deliverable MWs, as applicable, by May 5 2023, in accordance with Attachment S of the NYISO Open Access Transmission Tariff.

Once NYISO issues the revised CY21 ASDU Study report, any remaining Developers in the CY21 ASDU Study whose Project Cost Allocations increase or whose Deliverable MW decrease, as a result of such revised report, will be part of a Subsequent Decision Period.

If there is no increase in Project Cost Allocations or decrease in Deliverable MW in the revised CY21 ASDU Study report, no Developer will be provided with the option to accept or reject a Revised Project Cost Allocation in a Subsequent Decision Round and NYISO will issue a notice for Developers to post Security, as applicable. Developers will then have five (5) Business Days to (1) pay cash or post Security to the applicable Transmission Owner(s) for SUFs and (2) to pay cash or post Security for Headroom to the applicable prior Class Year Developer(s).

If, however, there is an increase to any Project Cost Allocations or decrease in any Deliverable MW for any project remaining in the CY21 ASDU Study, and Project Developers in the Subsequent Decision Round reject a Revised Cost Allocation for SUFs, SDUs, or Deliverable MW, the NYISO will prepare and issue another revised CY21 ASDU Study report with Revised Project Cost Allocations and Deliverable MWs, as applicable.
