Re: Class Year 2021 Notice of the Completion of the Annual Transmission Baseline Assessment Study Cases

Dear Class Year 2021 Projects:

This serves as notice of the NYISO's completion of the Annual Transmission Baseline Assessment study cases for Class Year 2021.

The NYISO has determined that the Annual Transmission Baseline Assessment (ATBA) study cases will be completed by August 4, 2021.

Withdrawal from the Class Year Study

In accordance with Section 30.8.1.2 of Attachment X to the NYISO Open Access Transmission Tariff (NYISO OATT), a Class Year Project may withdraw from the Class Year Study prior to the completion of the ATBA study cases.

If a Class Year Project elects to withdraw entirely from the Class Year at this juncture, it must provide a notice to the NYISO by emailing InterconnectionSupport@nyiso.com **on or before August 4, 2021**. After August 4, 2021, a Class Year Project may only withdraw from the Class Year Study by withdrawing from the Interconnection Queue entirely; provided, however, a Class Year Project will still be afforded the opportunity rejecting its cost allocation for System Upgrade Facilities in the decision process following Operating Committee-approval of the Class Year Study.

Please note that if a Class Year Project Developer elects to withdraw its project entirely from the Class Year at this juncture, its initial entry into Class Year 2021 will constitute one of the two Class Years that a project may enter under Section 25.6.2.3.4 of Attachment S to the NYISO OATT.

Different Location CRIS Transfer Requests

Section 25.9.4 of Attachment S to the OATT allows CRIS to be transferred on a bilateral basis between an existing facility within the NYCA and a new facility at a different location within the NYCA to the extent that the transfer satisfies the Deliverability Interconnection Standard in a Class Year Study. In order for such a transfer to be evaluated in the Class Year 2021 Study, the parties involved in the transfer transaction must notify the ISO **on or before August 4, 2021** the MW level of

capacity rights proposed to be transferred. Such notice should be provided by email to InterconnectionSupport@nyiso.com.
