Re: Class 2008 – Notice of Security Posting Defaults – Round 3 Cost Allocation

Dear Developer Representatives:

On January 4, 2010, a notice was sent to you regarding the *Class 2008 2nd Round Decision Results* – *Request to Post Security*. In that notice, the remaining Class 2008 Developers were instructed to post Security as applicable for the full amount of their respective Project Cost Allocations to the respective Connecting Transmission Owners by January 11, 2010.

Since NYISO had not received notification of all required Security postings by January 11, NYISO has been following up with the applicable Developers and Transmission Owners to ascertain the status of the Security postings related to the System Upgrade Facilities (SUFs) for two Class 2008 projects.

This is to inform you that Security Posting Defaults have been committed for the following two Class 2008 projects:

Under Attachment S of the NYISO OATT, the NYISO has removed these projects from the Class 2008 Facilities Study and issuing, with this notice, a revised Class 2008 Facilities Study and cost allocation (Round 3) for the now remaining Class 2008 Projects, which are:

In this case, the removal of the Seneca and Modern Projects from the Class 2008 Facilities Study has no impact on the ATRA or Deliverability Study results for the six remaining Class 2008 Projects. The Hudson Transmission project is still deliverable with Deliverable MW of 660 MW, and HTP's cost allocation for SDUs remains zero. The Project Cost Allocations for SUFs, including Headroom Reimbursements, remain the same as reported in the Second Round Addendum to the Class Year 2008 Facilities Studies.

Now, in accordance with Attachment S, each remaining Class Developer is required to provide within seven (7) calendar days, notice to the NYISO, in writing and via electronic mail, indication as to whether it shall accept ("Acceptance Notice"), or not accept ("Non-Acceptance Notice"), its revised Project Cost Allocation for SUFs. HTP also is required to provide either an Acceptance Notice or Non-Acceptance Notice to the NYISO regarding its cost allocation for SDUs. Therefore, I hereby request each of you provide such notice(s) to me by no later than January 27, 2010. Please send your notice to:

By <u>January 28, 2010</u>, NYISO will notify the Developers whether or not all the remaining Class 2008 Developers have accepted their cost allocations. If all Developers accept their cost allocations, Developers will then have five (5) business days from January 27th (until <u>February 3, 2010</u>) to post Security for SUFs to the applicable Transmission Owner(s). Developers that owe Headroom reimbursements also would be required to pay such reimbursements to the applicable prior Class Year Developer(s) as applicable. If, however, not all remaining Class 2008 Developers accept their cost allocation, NYISO would need to prepare and issue yet another revised Class 2008 Facilities Study report.
