Dear Expedited Deliverability Study 2020-02 Members:

This notice is served as the “Notice of Initial Decision Period to Expedited Deliverability Study 2020-02 Members.”

The Expedited Deliverability Study 2020-02 (EDS 2020-02) formally commenced on August 3, 2020. On July 30, 2021, the NYISO Operating Committee approved the EDS 2020-02 study results.²

In accordance with Section 25.5.9.2.4 of Attachment S to the NYISO OATT, each project for which to which this notice issued must respond to the NYISO in writing and via electronic email to InterconnectionSupport@nyiso.com within five (5) Business Days – **on or before August 6, 2021** – following the NYISO Operating Committee approval of the EDS 2020-02 study to indicate whether it shall accept (an “Expedited Deliverability Study Acceptance Notice”) or not accept (an “Expedited Deliverability Study Non-Acceptance Notice”) the Deliverable MW, if any, reported to it by the NYISO in the Expedited Deliverability Study report. A project with no Deliverable MW need not provide a notice.

Failure to notify the NYISO by **August 6, 2021** by a Developer as to whether it accepts or rejects its Deliverable MW, if any, will be deemed an Expedited Deliverability Study Non-Acceptance Notice.
