Re: Notice of Class Year 2012 Second Round Decision Results - Request to Post Security

Dear Developer Representatives:

On December 29, 2014, a notice was sent to you regarding the Second Round Class Year 2012 Facilities Study reports and corresponding cost allocations for System Upgrade Facilities (SUFs) and System Deliverability Upgrades (SDUs) for the remaining Class 2012 Projects, and requesting NRG Energy, Inc., to provide a notice of acceptance or non-acceptance of the revised cost allocation(s) and Deliverable MWs for the Q266 Berrians GT III project by January 5, 2015.<sup>1</sup> (Brookfield Renewable Power was not required to provide an acceptance or non-acceptance for the Second Round.) This is to inform you that the remaining Class 2012 Developers have accepted their respective cost allocations and Deliverable MWs, as applicable (see Attachment A).

Now, in accordance with Section 25.8.2.1 of Attachment S of the NYISO OATT, NRG Energy must satisfy its Headroom obligations to Astoria Energy II in accordance with Section 25.8.7.6 of Attachment S; and pay cash or post Security in the full amount of its Project Cost Allocation for SUFs to NYPA, the Connecting Transmission Owner **within five (5) business days from January 5, 2015** (*i.e.*, **by January 12, 2015**). "Security" is defined by the NYISO OATT as "a bond, irrevocable letter of credit, parent company guarantee or other form of security from an entity with an investment grade rating, executed for the benefit of the Connecting Transmission Owner and Affected Transmission Owner(s), meeting the requirements of Attachment S, and meeting the commercially reasonable requirements of the Connecting Transmission Owner(s)."

I request NRG Energy to notify me when it has made payment or posted Security for its respective Project Cost Allocation for SUFs and for its Headroom obligations. By copy of this notice, I request NYPA to confirm to me that such payment/posting for SUFs has been made and meets their requirements.

In the event that any Security Posting Default occurs, NYISO will, if necessary, prepare and issue another revised Class Year 2012 Interconnection Facilities Study report and cost allocation, in accordance with the requirements of Attachment S.
