This notice is served as the "Notice of Initial Decision Period to Expedited Deliverability Study 2023-01 Members."

The Expedited Deliverability Study 2023-01 (EDS 2023-01) commenced on February 24, 2023. On February 15, 2024, the NYISO Operating Committee approved the EDS 2023-01 study results.²

In accordance with Section 25.5.9.2.4 of Attachment S to the NYISO OATT, each project for which to which this notice issued must respond to the NYISO in writing and via electronic email to InterconnectionSupport@nyiso.com within five (5) Business Days – on or before February 26, 2024 – following the NYISO Operating Committee approval of the EDS 2023-01 study to indicate whether it shall accept (an "Expedited Deliverability Study Acceptance Notice") or not accept (an "Expedited Deliverability Study Acceptance Notice") or not accept (an "Expedited Deliverability Study Point accept to it by the NYISO in the Expedited Deliverability Study report. A project with no Deliverable MW need not provide a notice.

Failure to notify the NYISO by **February 26, 2024** by a Developer as to whether it accepts or rejects its Deliverable MW, if any, will be deemed an Expedited Deliverability Study Non-Acceptance Notice.
