Re: Notice of Class 2009 3rd Round Decision Results – Request to Post Security

Dear Developer Representatives:

On October 7, 2011, a notice was sent to you regarding the *Third Round Addendum to Class 2009 Facilities Studies* and corresponding cost allocations for System Upgrade Facilities (SUFs) and System Deliverability Upgrades (SDUs) for the remaining Class 2009 Projects, and requesting each of you to provide a notice of acceptance or non-acceptance of your revised cost allocation(s) and Deliverable MWs by October 14, 2011. This is to inform you that all the remaining Class 2009 Developers <u>have accepted</u> their respective cost allocations and Deliverable MWs, as applicable (see Attachment A).

Now, the remaining Class 2009 Developers must pay cash or post Security in the full amount of their respective Project Cost Allocations for SUFs and SDUs, as applicable, to the respective Transmission Owner(s) within five (5) business days from October 14, 2011 (i.e., by October 21, 2011), in accordance with Attachment S of the NYISO OATT. The applicable Transmission Owner(s) for each Developer are identified in Appendix A to this notice. Section 25.8.2.1 of Attachment S states, "[t]he Security can be a bond, irrevocable letter of credit, parent company guarantee or other form of security from an entity with an investment grade rating, executed for the benefit of the Connecting Transmission Owner and Affected Transmission Owner(s), meeting the requirements of Attachment S, and meeting the commercially reasonable requirements of the Connecting Transmission Owner and Affected Transmission Owner(s)." Additional details regarding this requirement are found in Attachment S.

I request each of the Developers to notify me when the Security has been posted or payment made, and by copy of this notice, I request the Transmission Owners to confirm to me that the Security postings/payments have been made and meet their requirements.

In the event that any Security Posting Default occurs, NYISO would need to prepare and issue yet another revised Class 2009 Facilities Study report and cost allocation, in accordance with Attachment S.

Note that the Class 2009 cost allocation included a calculation of Headroom payments from Class 2009 Developers to prior Class Year Developers for usage of functional and electrical Headroom on certain System Upgrade Facilities (see Attachment A). The applicable Class 2009 Developers also must make arrangements to pay Headroom reimbursement(s) to the applicable prior Class Year Developer(s) as indicated. I request any Developer required to make a Headroom payment to confirm to me that such

payment has been made.
