# Mission

- Create a forum to solicit stakeholder feedback on concepts and proposals for incorporating the cost of carbon emissions into wholesale energy markets to better harmonize the state's energy policies and the operation of wholesale energy markets.

# Objectives

- Facilitate an open and transparent process for stakeholders to inform the development of a proposal to incorporate the cost of carbon dioxide into the wholesale energy markets.
- Inform the assessment of impacts through analysis of scenarios developed with input from stakeholders.
- Encourage the full participation of stakeholders, including stakeholder presentations.
- The final deliverable will be a proposal to incorporate the cost of carbon dioxide into the wholesale energy market.
  - Following the Task Force, the proposal will be considered in the NYISO's governance process consistent with the BIC and MC By-Laws.
