NYISO Special Management Committee Meeting

August 25, 2000 The Desmond Albany, New York

Minutes of Meeting

1. <u>Introduction and Meeting Objectives</u>

Mr. Harvey Reed, Vice Chairman of the Management Committee (MC), called the meeting to order and welcomed the members of the Management Committee (MC).

Mr. Reed suggested the following objectives for the meeting.

- Report and action on NYISO Reserve Market Enhancements & September 1 Compliance Filing
- Action concerning Stage 1 ICAP Extension
- Receive reports from NYISO staff and Committee and WG Chairpersons

2. <u>Vice-Chairperson's Report</u>

Mr. Reed suggested that the discussion of the Reserve Market changes parallel the discussion that was conducted at the 8/24 BIC meeting through utilization of a similar set of motions to build to a consensus. Hearing no objections, Mr. Reed suggested that the MC conclude the discussions prior to the sector caucus and follow the caucus with a series of motions.

3. PSC Request for Market Data

Mr. Rob Fernandez, NYISO Counsel, provided a discussion of the series of events and background leading to the recent PSC Order #00-E-1380 requiring the NYISO to provide the PSC Staff with access to confidential market information. (i.e. Bid Data).

Mr. Fernandez indicated that the NYPSC cites sections 2,5, Article 4, and section 66 of the PSC law to substantiate the data request. He added that the PSC requires access to the confidential data to support its role in ensuring reliability and reasonable electricity rates, responding to questions from other governmental entities, and addressing issues related to proposed mergers.

Mr. Fernandez noted that prior to the Order, the NYISO had denied PSC requests for access to confidential data consistent with the NYISO's Code of Conduct. Subsequent to the Order, the NYISO has discussed the ramifications of the order with the NYISO Board of Directors and Counsel and has concluded that it should seek protection for the requested data consistent with the Federal Power Act, PSC Law, and the NYISO Tariff.

Responding to a number of inquiries from MC representatives, Mr. Fernandez noted that the PSC access would be limited to viewing terminals within the NYISO Control Center, and that PSC staff members would not be allowed to exit the Control Center with any materials other than their own personal notes. Only designated members of PSC Staff would be allowed to have access to the confidential data and when data regarding specific MPs is released in the form of staff notes, the affected MP will be notified of such disclosure. Mr. King clarified that the PSC use of NYISO computer terminals would be limited such that PSC staff could not transmit, nor receive, data and messages beyond the confines of the NYISO Control Center. In addition, remote or off-site access would not be possible.

Mr. Mark Younger, representing Indeck Energy Services, indicated that MPs would like to have access to information, with confidential portions redacted, as viewed by the PSC. Mr. Fernandez responded that such access would not be appropriate for Market Participants and reminded that the PSC does not take a financial position in the market. Mr. Fernandez offered to work with individual market participants to clarify the disclosure and notification process. He also added that the NYISO is still discussing the logistics for the PSC access and that a formal procedure would be finalized shortly.

Mr. Paul Gioia, Counsel for the NY Transmission Owners, suggested that the NYISO and the PSC find a way to share information regarding the performance of the markets and the reasons for the observed price behavior in the markets, without disclosing specific confidential information. He added that this information would be helpful in addressing the concerns of market participants, enhancing confidence in the NYISO markets, and facilitating the ability of the market participants to assist the NYISO in resolving market problems. Mr. Fernandez responded that the NYISO would take the request under advisement in its discussions with the PSC to finalize the logistical arrangements for the PSC access.

4. Reserves Market September 1 Filings

Mr. Bill Museler, CEO of the NYISO, thanked the MC representatives for their assistance with both the Volunteer Reserve Working Group, and their recent input to the NYISO's draft FERC Compliance filing (for September 1st). Mr. Museler reported that considerable progress has been achieved and as a result, three proposed tariff changes will require the consideration of the MC at today's meeting. Mr. Museler noted that the filing and the tariff changes contained therein, will allow the reserve markets to function as originally envisioned within the tariff and consequently are not intended to include further enhancements or functionality not already stipulated in the tariff. Mr. Museler then introduced Mr. Ted Murphy of Hunton & Williams, who has been assigned the lead in preparing the draft compliance filing and revised tariff language.

Mr. Murphy reviewed the salient points of the draft tariff document noting areas which required additional input and clarification. He also addressed a number of clarifying questions from MC representatives.

Mr. Ray Kinney asked that the minutes reflect NYSEG's reservation of rights, with respect to the Operating Reserves issues, as follows: "NYSEG'S participation on the Management

Committee and vote in this matter are without prejudice to and in no way constitute a waiver of NYSEG's rights with respect to Operating Reserve Charges".

Following the discussion of the existing NYISO draft compliance filing, the MC acted on the following motions:

Motion01: Motion to accept the NYISO proposal for locational clearing prices and special LI mitigation to guarantee that LI clearing price is not higher than price in the East outside LI (to be implemented by 11/01/00). As part of that mitigation, incremental Bid Production Cost Guarantees resulting from the commitment of LI resources to meet any specific LI local requirements for the purpose of providing operating reserves when such resources are mitigated shall be borne by Long Island customers. (Subject to NYISO implementation)

The motion was passed with 94% for and 6% against.

Motion 02: Motion that the NYISO Lost Opportunity Cost proposal for 10 minute NS and SR resources be adopted. Opportunity Cost will be based on individual unit LOC and unit selection will be done on a non prorata basis. NS LOC change will be retroactive to June 1, 2000. Pending elimination of prorata selection, LOC for unscheduled GT capacity is limited to the size of the largest GT.

The motion was passed with 100% in favor.

Motion 03: Motion to accept the NYISO proposal to continue mandatory bidding for 10 minute NS resources east of Total East until May 1, 2000 and let the Bid Caps lapse on Oct. 31, 2000 per the Tariff. (Motion was amended – see Motions #04, #05 & #06)

Motion 04: Motion to amended motion #03 to read: Motion to continue mandatory bidding for 10 minute NS resources east of Total East until May 1, 2001 and to require Bid Caps to remain in effect through the winter capability period ending April 30, 2001 via a tariff change.

The motion failed with 56.48% for and 43.52% against.

Mr. Reed suggested that the MC recess for lunch and sector caucus. At this time, Mr. Reed requested that each sector designate two individuals to work with the NYISO to finalize the language and provide any additional input needed for the September 1st compliance filing.

Following the sector caucuses, a discussion ensued regarding the ability of a prospective generation owner to vote, who had registered as a member of the end-use sector since the specific plant was only in the planning stages (article 10) at this time. Mr. Gioia noted that it was never the intent of the ISO Agreement that such parties would be considered "end users" and that the issue would need to be addressed expeditiously. Mr. Ira Freilicher of Hunton & Williams, Counsel to the NYISO, clarified that a party may elect to become a member of any sector for which it is qualified, but absent a change in status, must remain in the chosen sector for one (1) year. Mr. Freilicher noted that the entity in question does have an office in New York City and thus under the terms of the NYISO Agreement, qualifies to join the end-use

sector of the MC. At such time as the entity's status changes and it becomes eligible to join the generation sector, the ISO agreement provides for this transition. Mr. Feinstein of Caithness Energy, L.L.C., indicated that it was not the intent of his client to skew the MC voting process and therefore, until such time as Caithness Energy, L.L.C. could properly join the generation sector, he would abstain from any further votes taken by the committee. In doing so, Mr. Feinstein requested that the MC consider modifying the eligibility requirements of the generation sector to address this specific scenario. Mr. Freilicher indicated that NYISO Counsel would take the request under advisement.

Following the discussion, the MC resumed action on the following motion:

Motion 05: Motion to amend Motion #3 to continue mandatory bidding for 10 minute NS resources east of Total East until May 1, 2001 and to continue bid cap in this market until March 1, 2001.

The motion was passed with 58.73% for and 41.27% against.

Motion 06 (Motion #03 as amended by motion #05): Motion to continue mandatory bidding for 10 minute NS resources east of Total East until May 1, 2001 and to continue bid cap in this market until March 1, 2001.

The motion failed with 57.30% for and 42.70% against.

Motion 07: Motion to continue mandatory bidding for 10 minute NS resources east of Total East until May 1, 2001 and to establish a \$15/MW bid cap from November 1, 2000 through December 31, 2000 and raise that to \$30/MW through April 30, 2001 and expire effective May 1, 2001. The motion passed with 62.58% for and 37.42% against.

5. Lunch and Sector Caucuses

The MC adjourned for lunch and sector caucus at approximately 12:20 and resumed the meeting with Item 4 at approximately 1:15 pm.

6. Stage I ICAP Extension

Ms. Gina Fedele of Hunton & Williams reviewed the BIC action on a proposed revision to the Stage I ICAP tariff language addressing the implementation of Recall Bids. Ms. Fedele noted that the original language was found to be overly ambitious by both the NYISO and the MPs with regard to the functionality that could reasonably be expected to be implemented by the NYISO in the short term.

Motion 08: A motion was moved to accept the BIC approved tariff modifications regarding recall bids. Mr. Scheiderich seconded the motion, which was subsequently approved by a show of hands with 100% approval.

Mr. Ray Kinney of NYSEG noted that NYSEG's support of this motion was subject to the subsequent revision of the ICAP manual to reflect the approved change.

7. Northeast DAM Scoping Study

Mr. King presented a series of PowerPoint slides illustrating the intent of the first phase of work under the ISO-MOU Northeast DAM project, as well as a proposal for improving Market Participant involvement in the vendor selection and proper review activities. Mr. King noted that the issue was discussed at the recent ISO-MOU Business Practices meeting and that a venue for improving Market Participant involvement could be the utilization of the newly formed "SEAMS TEAM," chaired by Ms. Marjorie Philips of the PECO Power Team. Mr. King explained that during the vendor selection period, the participating ISOs/MOUs would provide descriptive information to the Seams Team regarding the salient points of each prospective vendors proposal. Market Participants could then review and provide comments prior to the selection of the vendor by the ISOs. Mr. King added that upon initiation of the work, Market Participants would have ample opportunity to review and comment on the work in progress. Following the completion of Phase I, Mr. King indicated that any recommendations to move forward would be addressed through the existing governance process within each individual ISO/IMO. To facilitate this process, Mr. King suggested that a presentation team consisting of representatives of the NYISO, Seams Team, and the vendor provide a detailed presentation of the results to the appropriate committee(s) within each participating ISO/IMO.

Ms. Philips, Chair of the ISO MOU Seams Team, noted that though she is not entirely in agreement with the motivation for the study, she does concur with the proposal for Market Participant involvement and the process suggested by Mr. King. Mr. King thanked Ms. Philips for her participation and suggested that others wishing to receive information on the vendor proposals should contact Mr. Tim Schmehl, Manager of NYISO Strategic Planning, to be included in future correspondence on the project.

Mr. King addressed a question regarding PJM's desire not to participate in the project and noted that PJM's non-participation would not preclude the vendor from examining PJM Market Structures. In addition, PJM, in the view of the NYISO, would not be precluded from participating at some later time, should PJM reconsider.

8. New Business

Mr. Bill Jaeger of Con Edison indicated that Con Edison intends to bring forth a motion to the next regular MC meeting regarding the extension of Bid Caps through the Winter Capability Period. Mr. Reed responded that the MC would take the notice under advisement.

9. Adjournment

The meeting was adjourned at 2:29 pm.
