**Re: Notice of Change of Location of Annual Meeting of  
Niagara Mohawk Power Corporation of the Annual Update to the  
Formula Transmission Service Charge Under the NYISO OATT

Dear Secretary Bose:

On June 14, 2010, Niagara Mohawk Power Corporation d/b/a National Grid (“National Grid”) submitted for informational purposes its Annual Update of certain components of its TSC Formula rate (“Informational Filing”), which sets National Grid’s Wholesale TSC under the New York Independent System Operator Open Access Transmission Tariff (“NYISO OATT”). Within that Informational Filing, National Grid provided its required “Notice of Annual Meeting,” scheduled to be held on June 29, 2010.

At the request of several of National Grid’s transmission service customers, National Grid is relocating that Annual Meeting to be held in Albany, New York, rather than the previously noticed location at National Grid’s offices in Waltham, Massachusetts. Therefore, National Grid respectfully requests that the Commission accept for filing this revised “Notice of Annual Meeting” in the above-captioned docket.

**I. Notice of Annual Meeting, Revised Location**

In accordance with Attachment H, Section 9.4(b)2, of the NYISO OATT, National Grid will hold an annual meeting to present and explain the Annual Update and respond to any questions. This meeting is open to all Interested Parties.
