

# Market Performance Highlights for September 2006

- September experienced lower loads and fuel prices that contributed to lower prices this month compared to August.
- LBMP for September is \$51.89/MWh, down from \$101.33/MWh in August.
  - Average monthly cost is \$54.38/MWh, down from \$105.42/MWh in August.
  - Day Ahead and Real Time LBMPs have decreased from August.
- Fuel prices are all down this month.
  - Kerosene is \$13.96/mmBTU, down from \$16.26/mmBTU in August
  - No. 2 Fuel Oil is \$12.12/mmBTU, down from \$14.12/mmBTU in August
  - No. 6 Fuel Oil is \$7.63/mmBTU, down from \$9.18/mmBTU in August
  - Natural Gas is \$5.14/mmBTU, down from \$7.86/mmBTU in August
- Uplift has decreased this month relative to August 2006.
  - Uplift (not including NYISO cost of operations) is \$0.46/MWh, down from \$2.28/MWh in August.
  - Total uplift (Schedule 1 components including NYISO Cost of Operations) decreased from \$46.7 million in August 2006 to \$14.7 million in September 2006.
- Regulation average prices, as well as ten and thirty minute reserve average prices, have decreased from August.
- The virtual market showed a decrease in activity from August.

# **External Comparison Ontario IESO\***







