# MINUTES OF THE MEETING

### 1. Introduction and Meeting Objectives

Joe Oates, Chairman, called the meeting to order at 12:33 p.m. and welcomed the members of the Management Committee ("MC"). The only meeting action item is to approve the minutes of the previous meeting. Mr. Oates announced that the Project Prioritization Team will be meeting Wednesday of this week. Mr. Oates will report findings. The May 5<sup>th</sup> MC meeting will be a conference call. The July MC meeting will be in Saratoga Springs. On July 6, the MC members will have a golf outing at their own expense. Today at 3pm there will be an oral argument in the two IPPNY appeals of Management Committee actions regarding in which sector(s) DRPs and DGs should participate in stakeholder governance.

### 2. Approval of the Minutes

Motion #1: Motion to approve the Minutes of March 2, 2004 MC meeting. Motion Passed unanimously.

## 3. President's Report

### Market Performance Highlights

Charles King of the NYISO reported that average costs for March 2004 were 34% less than March 2003 primarily due to moderate weather and lower fuel prices. The average monthly price for gas (in \$/mmBTU) was below that of Kerosene and No.2 fuel oil for the second month in a row. Virtual Load and Supply MW's have been increasing since January, as well as the percentages of Virtual Load accepted in the DAM. Revised Regulation Requirements went into effect on April 1, 2004.

### Standard Market Design ("SMD") 2.0 Update

Mr. King gave an update on SMD 2.0. Software defect validation has been completed for all the high severity software bugs from the Phase I Factory Acceptance Tests ("FAT"). This contract milestone was reached on schedule, as per the revised project plan. ABB software development activities for SMD Phase 2a were completed on schedule at the end of March. The SCADA/EMS software pre-FAT testing has been completed at the ABB facility, and Business Management Software ("BMS") pre-FAT testing is underway. The Phase 2a SCADA/EMS Factory Acceptance Testing started on schedule at the NYISO facility on April 13th. The SCADA/EMS FAT is scheduled to take three (3) weeks. The FAT for the BMS software is scheduled to start on May 3rd. The NYISO site testing and Market Trials plan are proceeding successfully. Upload/Download testing has started with NYPA; the full sandbox for all the MP's will be made available as soon as those tests are complete. A second SMD Technical Conference was held on March 31st. The target audience was market trial test participants, and the session was well attended.

## Presentation of Extraordinary Costs

Mr. King discussed the Extraordinary Cost process, and provided the status. A total of 22 claims have been received. Payments have been made for Emergency Energy purchases and reimbursement of extraordinary expenses incurred because of NYISO directions during the system restoration. The committee designated to review the claims has approved \$1, 207,444.08 in claims submitted to the NYISO YTD those claims have been paid in the April 2004 invoice. There are four claims outstanding.

### Report on Market Participant Readiness for SMD

This plan was developed to ensure Customers are aware of upcoming SMD training and testing activities. The plan is designed to reduce issues requiring resolution during deployment, and also to decrease the likelihood of unfavorable market impacts during deployment. The President's Report (April 2004) details the Readiness Program process, with timeframes for the major activities.

Training opportunities/dates defined thus far include:

NYMOC - April 19-22 and June 8-11; SMD2 Transition Course - May 4, 6, 13, 17 and June 2; SMD2 Transition for Accounting Staffs- May 17-18 (Includes May 17 SMD2 Transition).

Elaine Robinson informed the group that the Business Issues Committee ("BIC").will be asked to undertake a review of whether the NYISO's code of conduct appropriately addresses market participant - NYISO communications and to and propose appropriate modifications if necessary.

### 4. Update on Seams and Market Improvement Projects

Mr. King reported the following progress in resolving Seams Issues and Market Improvement Projects: Facilitated Checkout – work is moving along.

*E-Tagging* – will be deployed next month.

*Elimination of Rate Pancaking* – There is a meeting later this week between regulators in NY and NE to discuss the elimination of pancaked rates across the NY NE Control Area border.

Coordination of Cross-Sound Cable – The NYISO is in the process of finalizing a contract with the selected Scheduling Administrator. NYISO is also working on the End-State solution, to be deployed for Summer 2005.

Mr. King reported on the Quarterly Seams Meeting held in NYC on April 8, 2004. The NYISO will email each "sector" asking each sector to name their respective representatives in order to keep everyone apprised of upcoming meetings. The team added clarifying comments from HQ on their participation in facilitated checkout, as well as LIPA's interest in selling reserves into NE under the new Issue Under Discussion (Reserves Participation in Adjacent Regional Markets). The team added general cross-border controllable lines as a new project, and discussed interest in getting an update on E-Tagging within NY Market Services Working Group. Several requests were made to revisit this issue at the May MC meeting.

### 5. New Business

Wes Yeomans of National Grid ("NG") commented on the methodology the NYISO uses to allocate congestion rent shortfalls. The NYISO is not yet using the new congestion allocation procedure and NG feels using the old allocation process is not proper. Mr. Yeomans stated that NG's TSC and retail rates are incorrect due to the absence of the proper congestion shortfall allocation. NG is interested in what asset outages affect the amount of congestion rent shortfall they are paying. NYISO is working diligently to resolve the barriers to deployment of the new congestion shortfall methodology and is looking to get this out to the marketplace ASAP.

Mike Calimano of the NYISO reported on the NERC readiness audit. The audit was completed last week, with no negative comments from NERC.

Meeting adjourned at approximately 13:42 PM.
