 Identifies when a Provisional ACL Shortfall exists for a specific resource, for a selected Capability Period and month



#### **Current Functionality**

- Allows users to view resource Provisional ACL information
- Users can narrow the search by specific resource, zone, Transmission Owner or by resources with a shortfall
- Users can view the ACL kW values used to calculate the Verified ACL of the resource



#### New – "No Reported Data Filter"

- MPs may select "No Verified Data" from the "Reporting" search filter
- User enters search criteria, must select resource or Capability Period and "No Verified Data" from the reporting filter drop down
- System retrieves resources and associated enrollment data for each month where the resource was enrolled with an Provisional ACL and no approved verified metered load data record exists
- This also applies to Incremental ACL Data

#### **Verification Data**

- Provisional ACL kW values of the resource reported with the resource enrollment data for the selected Capability Period
- Shutdown kW resource Shutdown kW for the Capability Period and month selected
- Net ACL kW resource Provisional ACL kW value reported with the resource enrollment data for the Capability Period selected, less the Shutdown kW for the Capability Period and month selected
- Verified ACL kW DRIS calculated ACL kW for the resource from the import of the resource Provisional ACL verification file including TO/DADRP add-back kW and DSASP baseline kW values
- Raw Shortfall kW the difference between the Net ACL kW and the Verified ACL kW fields of the resource for the Capability Period and month selected



### Verification Data con't

- UCAP Equivalent of Shortfall kW UCAP equivalent of the Raw Shortfall kW
- Auction Sales kW the resource auction sales for the Capability Period and month selected
- AMD –Actual Metered Demand of the resources from all event and test hours in which the resource performed in the Capability Period selected. The lowest value is used for Response Type C and B and the highest value is used for Response Type G
- Applicable Shortfall kW the value of the resource shortfall based on the Provisional ACL Shortfall calculation for selected month and Capability Period



#### **Provisional ACL Details**

- View details of the resource Provisional ACL verification data by clicking the corresponding row in the Provisional Summary grid.
- The system expands a frame at the bottom of the screen, where additional resource ACL details are displayed

## Summary

- Provisional ACL verification data provides a snapshot of the resource Verified ACL based on import data. DRIS identifies when a shortfall exists for the selected Capability Period and month.
- Upon initial import of the resource's Provisional ACL verification file, DRIS will calculate the resource ACL and determine if a Provisional ACL Shortfall exists for resources in the file which pass all validations.
- Any resource which receives a Provisional ACL shortfall kW based on the Provisional ACL Shortfall Calculation performed in DRIS will be identified as having a shortfall.



## Summary con't

- Once final shortfalls have been determined, the user will have the option of using the "Reporting" filter option "No Verified Data," which will return resources enrolled with a Provisional ACL in the Capability Period selected, that did not have verification data imported during the reporting period
- DRIS provides this functionality for Incremental ACL as well



# Resource Responses to Events



#### View Resource Responses to Events and Tests

- Once the MP has successfully imported resource responses to an event or test, the response data can be viewed in DRIS
- DRIS calculates the Energy and Capacity Reduction
- DRIS provides the ability to view performance details by a specific event or test



## New Feature - Failure to Report

#### **New Reporting Filter - "Failure to Report"**

- When selected, it will return all resources that were required to respond to an event or test selected with a null metered kW value
- Resources which did not have event or test responses imported in DRIS will be identified by this feature



## Failure to Report for 2<sup>nd</sup> Test

- Returns all resources required to respond for the 2<sup>nd</sup>
   Test, which have not reported response data
- Resources which may appear in this filter include those resources enrolled with an Incremental ACL, a Change of Status or enrollment in the Capability Period after the first test of the Capability Period

## Summary

- The response data can be viewed in DRIS once the MP has successfully imported resource responses to an event or test
- New feature added to the Resource Responses to Event screen
  - Failure to Report
  - Failure to Report for 2<sup>nd</sup> Test
- It will return all resources that were required to respond to an event or test selected with no metered kW value
- No resources will be returned on either search prior to the Performance Factors being run for the applicable Capability Period
- SCRs may be subject to potential sanctions for failure to report the metered load data required for verification
