Mr. Smith also reported that the NYISO received 15 transmission project proposals and one non-transmission project proposal in response to the AC Transmission Public Policy Needs.

The working group's topics have included:

- Developing assumptions and scenario concepts for the 2016 Reliability Needs Assessment. A key topic of debate has been the treatment of capacity that has committed to export to other markets for part of the 10-year study window.
- •The NYISO has provided updates on the status of its on-going public policy transmission planning efforts, and has disclosed information about the identity of those projects that have been found viable and sufficient to address the Western NY Public Policy Need, as well as an overview of the project proposals submitted in response to the AC Transmission Public Policy Needs. NYISO has also recommended that the NYPSC require developers to address non-bulk system issues found in Western NY.
- •At the June 7, 2016 ESPWG meeting, the NYISO provided an overview of the results of its solar integration study. A draft report has been posted with the ESPWG meeting materials. Stakeholders should provide any comments by June 17, 2016.

ICAPWG – Mr. Liam Baker (EasternGen) reported that the ICAPWG has been working on the ICAP Demand Curve reset.

IPTF – The group did not meet.

LFTF – Mr. Bryan Irrgang (LIPA) reported that the 2016 Spring Economic Conference was held on June 6, 2016.
