## **Draft MINUTES OF THE MEETING**

# 1. Introductions, Meeting Objectives & Chairman's Report

Larry Dewitt of Pace Energy, Chairman, called the meeting to order at 9:03 AM and welcomed the members of the Management Committee ("MC"). The meeting objectives are to:

- Act on May 25, 2005 and May 27, 2005 Minutes
- Act on Proposed Revisions to the NYISO Investment Strategy Options for Market Participant Cash Collateral
- Act on Proposed Revisions to rules for NYISO Startup and Shutdown Undergeneration Penalties and Over-generation Payments
- Approveal of Revisions to Attachment S and Attachment X of the NYISO Open Access

Mr. Dewitt announced that Mario De Valentino has agreed to be the Vice-Chair of the BSP effective immediately.

# 2. Approval of the Minutes from the May 25 and May 27, 2005 MC Meetings

## Motion #1:

Motion to approve was moved by Ray Kinney and seconded by Neil Butterklee Motion to approve the Minutes from the May 25, 2005 and May 27, MC meetings.

## 2.3. President's Report

Charles King of the NYISO presented the President's Report on behalf of Mark Lynch, President and CEO of the NYISO, who was at the concurrent NYISO Board meeting.

Mr. King provided a status of the first two days of summer peak-load conditions since SMD2 implementation (June 13-14). He noted that the system performed well with no major operational issues.

Glenn Haake of IPPNY requested that the NYISO provide an update on the Sales Tax meeting with the Tax Department. Brad Kranz reported that he had been informed by Robert Fernandez, General Counsel, that the Tax Department is taking into consideration the different options available to address the tax issue. Any specific questions should be forwarded to Mr. Kranz for a more complete answer.

# 4. Billing Issues

Charles Garber, NYISO CFO, presented the billing issues update to the MC. Mr. Garber stated that the following items would be reflected in the February 2005 4-month true-up in the July 2005 invoice:

- February 2005 price corrections
- Day ahead margin assurance payment ("DAMAP") for reserves and regulation.
- February real-time sub-zonal load issue correction

Mr. Garber also noted that only May 8<sup>th</sup> and 9<sup>th</sup> 2000 will be reprocessed on the July invoice to comply with the March 4, 2005 FERC order regarding the ELR/ECA implementation. He added that the changes versus the prior billing for those days would be included as a manual adjustment on the July invoice. (Note: Based upon Market Participant feedback and additional input at the BAWG Meeting on June 23, 2005, this plan was changed such that the entire month of May 2000 will be reprocessed and will be included in the July invoice.)

Steve Wemple of Con Ed Solutions asked, in reply to Mr. Garber's statement that May 8<sup>th</sup> and 9<sup>th</sup> will be rerun and a bill calculated for both days based on the delta, whether the <u>calculation</u> detail <u>calculation</u> for those days <u>will</u> be available to the Market Participants.

Mr. Garber agreed to report back to the MC regarding the level of details that can be provided to MPs on the May 8<sup>th</sup> and 9<sup>th</sup> bill calculation. [Note: Based upon subsequent Market Participant feedback and additional input at the BAWG Meeting on June 23, 2005, this plan was changed such that the entire month of May 2000 will be reprocessed as a re-bill and will be included in the July invoice.] (See note above regarding the subsequent change in plans for handling May 8<sup>th</sup> and May 9<sup>th</sup> on the July 2005 Invoice.)

On the final bill closeout, Mr. Garber noted that the NYISO plans to proceed closing out five months at a time and eventually would like to accelerate the process in the Fall of 2005 to close out up to 12 months at a time.

# 5. Proposed Revisions to the NYISO Investment Strategy Options for Market Participants' Cash Collateral

-Mr. Garber, NYISO CFO, reviewed both the current practice and the proposed changes for managing Mmarket Pparticipants' cash collateral.

After researching several numerous options, NYISO recommends transferring existing cash collateral deposits from Key Bank to BlackRock, Inc. BlackRock is the investment-banking arm of PNC Financial Services, has more than \$390 billion under asset management, and has experience managing ISO Market Participant's cash collateral deposits.

Mr. Garber discussed the details of a two-phased approach which will feature the use of two alternative money market funds (one taxable and one non-taxable) to be implemented in the August/September time frame, to be followed by a second phase which will incorporate the use of two additional bond funds that will occur in the October/November time frame, pending the approvals by the Board and approved by FERC of required tariff changes. Mr. Garber also reviewed the specific tariff changes required to implement this proposal.

Bruce Blewiss of DC Energy suggested modifying the specific tariff language to say "the customer election shall be in writing and shall not be changed more than allowable by internal ISO protocol.".

The Management Committee (MC) hereby approves the proposal to allow for revisions to NYISO investment strategy options for Market Participant cash collateral, as noted in Phase II of the presentation to the MC on June 21, 2005 and approved by the Business Issues Committee on June 10, 2005. The MC hereby approves revisions to Attachment W of the Open Access Transmission Tariff, and Attachment K of the Services Tariff, as presented to the MC at the June 21, 2005 meeting, and requests that the Board authorize a filing to the FERC pursuant to Section 205 of the Federal Power Act to amend accordingly.

# 6. Proposed revisions to the rules for NYISO Startup and Shutdown Undergeneration Penalties and Over-generation Payments.

Robert Thompson, of the NYISO, reviewed the proposed tariff changes and associated implementation requirements for the removal of startup and shutdown generation penalties.

Following a brief discussion, Howard Fromer of PSEG requested that the minutes reflect that the startup period that is designated by a customer must be designated as a startup period within 24 hours of the schedule or else the unit would not be eligible for compensation and would be subjected to penalties.

The Management Committee (MC) hereby approves the proposed new rules to exempt generators of their under-generation penalties during startup and shutdown periods, and to authorize payment for all energy produced during these periods, as presented to the MC on June 21, 2005, and approved by the Business Issues Committee on June 10, 2005. The MC requests that the Board authorize a filing to the FERC pursuant to Section 205 of the Federal Power Act to amend the tariff accordingly.

(Motion passed unanimously by show of hands)

# 7. Approval of Revision to Attachment S and Attachment X of the NYISO Open Access Transmission Tariff.

Liz Grisaru of the NYISO presented the Approval of Revision to Attachment S and Attachment X of the NYISO Open Access Transmission Tariff.

Liam Baker of Reliant requested that the minutes reflect that the proposed amendments do not supercede the settlement agreements. Ms. Grisaru agreed.

Rich Dewey of the NYISO updated the MC on the SMD2 and upcoming software deployments. Mr. Dewey gave a presentation highlighting both the recent controllable lines and SMD2 enhancement deployments. The presentation also provided details on the upcoming June, July and September software deployments.

#### 9. **New Business**

Doreen Saia of Mirant asked if the SMD2 is ready to accommodate the new operating protocol for the PSEG/Con Ed/PJM/NYISO 1000 MW wheel.

Mike Calimano responded that the NYISO intends to go over the operating protocol at the next Operating Committee and that the NYISO is on track for the July 2 implementation.
