NYISO Business Issues Committee Meeting Minutes

Special Meeting Via Conference Call on the TCC Credit Policy Proposal

I. Welcome and Meeting Objectives

Mr. Larry Dewitt, Vice Chair of the Business Issues Committee, called the teleconference to order at 10:33 A.M. He noted that the objective for today's meeting is to discuss and act on the TCC Credit Policy Proposal. Also, Mr. Kevin Jones, representing the NYISO, plans to describe NYISO's concerns and offer amendments to the original proposal.

II. Motion to Amend the TCC Credit Policy

Ms. Doreen Saia, on behalf of Mirant Corporation, distributed her proposed amendment and accompanying presentation on the TCC Credit Policy beforehand. The rationale for her proposed TCC Credit Policy Amendment is to address exposure attributable to congestion rent obligations of Primary Holders in excess of collateral required at time of TCC auctions. The motion she presented is as follows:

It is hereby moved that the proposal to offset collateral requirements for TCCs as more specifically delineated in the October 10, 2002 BIC meeting TCC presentation is approved. The BIC requests that the Management Committee approve this motion at its October 16, 2002 meeting and the BIC further requests that the NYISO Board approve this motion as soon thereafter as possible to include this proposal in the overall TCC credit filing to be made with the FERC expeditiously.

NYISO's Amended Motion

Mr. Kevin Jones, on behalf of the NYISO, presented an amended motion to Ms. Saia's original amendment. Mr. Jones stated that because of issues that may arise in bankruptcy, the NYISO is unable to support the amendment to the TCC Credit Policy that would have netted collateral requirements for offsetting TCCs. However, the NYISO does think that the second part of the TCC Credit Policy ("Part B") should be more clearly described. The NYISO has offered an amendment to the Motion to approve a change to Part B of the TCC Credit Policy.

Mr. Stuart Nachmias, of Consolidated Edison, noted that Mr. Jones' amendment was distributed too late for reviewing. He asked that the Meeting Minutes note that BIC Meeting Materials need to be provided earlier.

Several Market Participants, including Mr. Jim Scheiderich, of Select Energy, and Mr. Alan Babp, of PP&L Energy Plus, noted that there is no industry agreement as to what the term "Mark-to-Market" means and that clarification is needed in the proposed amendment. Mr. Nachmias, however, believed that "Mark-to-Market" is a well-known concept and that the NYISO is using a consistent methodology throughout the proposal. For clarification, Ms. Saia suggesting inserting the following language in the proposal: "as defined for these purposes...according to the formula below." Mr. Scheiderich agreed with Ms. Saia's insertion.

The BIC then voted upon the following motion:

Motion #1:

It is hereby moved that the proposal to clarify the second part of the TCC Credit Policy, as presented and modified in the October 10, 2002 BIC meeting TCC presentation, is approved. The BIC requests that the Management Committee approve this motion at its October 16, 2002 meeting and the BIC further requests that the NYISO Board approve this motion as soon thereafter as possible to include this proposal in the overall TCC credit filing to be made with the FERC expeditiously.
