Minutes of the Meeting

1. <u>Introduction and Meeting Objectives</u>

Mr. Lou Rana, Chairman of the Management Committee, welcomed the members and reviewed the objectives of the meeting. Mr. Rana noted that, in accordance with the discussion at the March 9th MC meeting concerning sanctions, the MC had reconvened to consider adopting sanctions for the Installed Capacity market currently in effect. Mr. Rana further noted that the Stage I ICAP filing, then pending before FERC, contained sanctions that would be applicable to the proposed ICAP market if FERC approved the Stage I filing prior to April 1, 2000.

2. <u>Discussion</u>

Mr. Ted Murphy, Hunton & Williams, reviewed the draft tariff (dated March 16, 2000) containing proposed ICAP sanctions. Mr. Murphy explained that the draft tariff was based on Mr. Jerry Ancona's proposed sanctions, which had been approved by the MC at the March 9th meeting.

Some members of the MC expressed the view that the sanctions contained in the draft tariff did not provide adequate incentives to LSEs to purchase sufficient ICAP ahead of the capability period. Other members expressed a concern that the draft tariff would limit trading of ICAP within the capability period. Mr. Ancona agreed with a recommendation to delete certain sections of the draft tariff to address this concern.

After extensive discussion comparing the draft tariff based on Mr. Ancona's sanctions and the sanctions proposal that had been presented at the March 9^h MC meeting, a motion was made and seconded to adopt the draft tariff based on Mr. Ancona's sanctions, dated March 16, 2000, as amended at the March 20th meeting.

The motion passed by a vote of 68.13%

3. Adjournment

The meeting was adjourned at approximately 12:00 noon.
