MOTIONS FROM THE MEETING

Motion #1:

The Business Issues Committee (BIC) hereby recommends that the Management Committee approve revisions to the NYISO's Market Services Tariff and OATT that were discussed with the Market Monitoring Task Force and presented to the BIC.

The NYISO proposes to:

1. clarify the definition of, and method that the NYISO uses to calculate "Constrained Hours" in Section 3.1.2(b)(1) of Attachment H to the Market Services Tariff (the "Market Mitigation Measures" or "MMM");
2. correct a typographical error in Section 3.1.4(a) of the MMM;
3. modify the method used to determine Bid-based reference levels in Section 3.1.4(a)(1) of the MMM by specifying the hours of the day that the NYISO uses/will use to develop Bid-based reference levels, and by specifying when the NYISO will exclude certain Bids from its development of Bid-based reference levels;
4. modify the method used to determine LBMP-based reference levels in Section 3.1.4(a)(2) of the MMM by removing the words "for similar hours or load levels" and specifying when the NYISO will exclude certain LBMPs from its development of LBMP-based reference levels; and
5. update the definition of "Out-of-Merit Generation," in both the OATT and Market Services Tariff to more clearly reflect its common meaning/usage.

Motion passed unanimously with abstentions.
